Town of Montague the Awarding Authority invites sealed bids for Rutter's Park Improvements - Phase One Project in the Village of Lake Pleasant, Montague, Massachusetts, in accordance with the documents prepared by GZA GeoEnvironmental, Inc. dated January 23, 2019.

The Project consists of improvements for a Playground, premanufactured Pavilion, new parking area and other site furnishings and plantings.

The work is estimated to cost \$ 225,000

Bids are subject to M.G.L. c.30 §§ 39M and to minimum wage rates as required by M.G.L. c.149 §§26 to 27H inclusive and Davis Bacon and shall pay the higher of the two rates.

General Bids will be received until 2:00 P.M., February 20, 2019 and publicly opened, forthwith.

Bids shall be filed in a sealed envelope, bearing the title BID#2019.01 – Rutter's Park Improvements - Phase One Project, per specifications, delivered to: Montague Town Hall, Selectboard's Office, 1 Avenue A, Turners Falls, MA 01376 and received no later than the date & time specified above.

General bids shall be accompanied by a bid deposit that is not less than five (5%) of the greatest possible bid amount (considering all alternates), and made payable to the Town of Montague

This deposit will be refunded for up to two sets for general bidders upon return of the sets in good condition within thirty days of receipt of general bids. Otherwise the deposit shall be the property of the Awarding Authority. Additional sets may be purchased for \$50.00. Bidders requesting Contract Documents to be mailed to them shall include a separate check for \$40.00 per set for UPS Ground (or \$65.00 per set for UPS overnight), payable to BidDocs ONLINE, Inc., to cover mail handling costs.
