THE BOARD OF APPEALS VOTED:

To grant a Special Permit (Section 5.1.4 Alterations) and variance of the rear yard setback (Section 5.4.5). The approval allows the removal of a 6 ft. by 14 ft non-conforming porch with a 12 ft. by 14 ft covered porch within 16 ft. of the rear property line.

<u>The Board of Appeals finds</u>: that the increase in non-conformity does not compromise the intent of a rear yard setback and has no more detrimental affect on the surroundings than the existing porch.
