THE BOARD OF APPEALS VOTED: To grant a Special Permit to allow area and frontage reduction were public water and sewer lines exist (Sections 5.4.1(c) & 5.4.3(c)). An existing house is located at 98 Montague Street. and a vacant lot abutting at the rear is located at (75) Oakman Street. The request allows the reestablishment of two separate lots fronting on two separate streets. Each lot has approximately 83 feet of frontage and has approximately 10,790 sq. feet of area. The Board recognizes the intent of the applicants to maintain the separate buildable status of the unused lot and the intent of the By-laws to protect that privilege.
