THE BOARD OF APPEALS VOTED:

To grant modifications to the requirements of By-law Section 7.3.5 with conditions for previously approved Home Occupation Special Permit #05-17:

- To allow an over sized 2-foot by 3-foot sign for the Equipment Sales business that may be placed at or near the driveway entrance.
- To deny the request to display heavy equipment at the street line, front yard or side yard of the house.
- To allow with conditions the modification to the original restriction (#05-17) limiting exterior display of heavy equipment vehicles to the rear building and parking lot by allowing additional area of display of up to 3 vehicles for sale to immediately in front and to the south side of the existing residential garage but behind the rear line of the house.

This permit approval is not transferable to another party at this location without further proceedings and approval of the Board of Appeals.

THE BOARD FINDS:

That the front yard and side yard display is too intrusive to the public and not consistent with the purpose and intent of a home occupation. The request is made pursuant to Section 7.3.10 of the Montague Zoning By-laws.
