**THE BOARD OF APPEALS VOTED:**

To grant a Special Permit to allow the conversion of a professional office space into 2 – one bedroom apartment in an existing 4 unit multi-family dwelling creating a 6 unit building pursuant to Section 5.2.10 (multi-family use) and to grant the dimensional relief required pursuant to Sections 5.4.1(c) and 5.4.3(c) (Exceptions to minimum lot area and frontage) of the Montague Zoning Bylaws.

Conditions: The Board requires 1 parking space per unit {6 parking spaces}. Apartments shall be approximately equal in size and follow existing separation walls to the extent practical. The board further grants variance to (Minimum floor area) Section 5.4.7 to the extent required to meet the conditions above.

Note: The Board found no objection to a single apartment conversion with or without retaining the office space.
