The Board of Appeals finds:

The septic system of 53 East Taylor Hill Road was installed on land of 55 East Taylor Hill Road. The owners of 53 East Taylor Hill Road propose to acquire approximately .85 acres of land with the septic system from 55 East Taylor Hill Road.

THE BOARD OF APPEALS VOTED:

To grant variance to Section 5.4.1 (Minimum lot area - 2 acres) to allow the reconfiguration of the two abutting lots for the purpose of allowing the owners of 53 East Taylor Hill Road to acquire and join the land their septic system occupies to their current lot. The relief will allow a lot area of 1.15 acres of land at 55 East Taylor Hill Road where two acres is otherwise required.
