The Board of Appeals finds: The size, scale, shape, location and height of the proposed solar array in relation to the abutting uses, lots and buildings are appropriate. The Board concludes there is minimal impact on the neighborhood and the environs. This Special Permit modifies previous permit #12-19 for solar installation.

THE BOARD OF APPEALS VOTED: To grant a Special Permit pursuant to Section 7.9.3(d) to allow the instillation of a 390 sq. ft., 22 panel, 5' tall ground-mounted solar array to be located no closer than 15 feet from the north side property line and approximately 185 feet from Turners Falls Road.
