#### **Pole Location Hearing**

#### Discussion:

- Kuklewicz expresses concern regarding the now-redundant poles.
- Mike Kane, municipal liaison for Eversource, states that work is being done to remove the double poles.
- Jamie Beauchesne, overhead supervisor in Montague, states 34 double poles have been pulled and more will continue to be.
- In response to a question by Ellis, Beauchesne states that temporary transformers would be removed as part of closing the project out this year.

#### **COVID-19 Updates and Action Items**

- **Update on Montague COVID case counts and other summary data**  
Active cases from January 24 through February 6 equals 21; cumulative cases from October 1, 2020 through February 6, 2021 equals 184; and positive cases from March 1, 2020 through February 6 equals 213.
- **Review Reopening Plan Relative to any changes in trends**
  - The Town Hall will be open to manage public entry beginning tomorrow morning from 10:30-12:30 and 3:30-5:30. All previous requirements are in place.
  - Ellis stresses that opening of the Town Hall is due to the fact that there is some business that is important to be conducted in person. He hopes that people will still make use of email, phone, and other means of communication and transaction. There continues to be a drop box at the front of the building, as well as a collection box.
  - Boutwell mentions that due to an outbreak in Amherst, another slow-down will be happening in that area as well as neighboring communities.
  - All three Montague Public Libraries will be open for half-hour appointments beginning Tuesday, February 9.
- **Update on Vaccine Distribution**
  - Zellman states that most of our 75+-year-old residents have scheduled their first vaccinations through their primary care physicians. Those that haven't are being funneled to Greenfield by Council of Aging and the Board of Health.
  - We have partnered with Greenfield and the FRCOG, and we will be hosting a clinic sometime the week of March 8. We will be rotating as clinic hosts with Deerfield, Buckland, Bernardston, etc., as we go through the phases.
  - Potter clarifies that 80-85% of our 75+-year-old residents have been contacted.
  - Ellis suggests that the Board of Health pursue the arrangement regarding providing manpower for the Greenfield clinics.
  - In response to a question by Kuklewicz, Zellman states he will contact Greenfield Chief of Staff Danielle Letourneau to find out whom health care professionals can contact to offer Greenfield support.
  - Ellis states that Greenfield is working on defining the nature of the roles and skill sets of the individuals that are most in need. He suggests that people who want to volunteer should contact our Board of Health.
- **Review of any Updated State Guidance or Orders**
  - The Baker-Polito Administration is trying to make the public more aware of their campaign, which includes a new call center for residents 75 and older to provide information on the vaccine.
  - There is a vaccine scheduling resource line on the mass.gov website, which will be open Monday through Friday from 8:30-5:00.
