 - o If we look at the Level Services request, we are running a budget shortfall of between \$430,000 and \$431,000.

- o If we look at the 2% reduction, we are able to reduce expenses by about \$157,000 (without having to do any staffing reductions).
- o The major variable in our budget is the health insurance increase. We are holding a place for another 18% to 20% increase (\$582,000).
- We will dig more into this budget in January.
- o We will need to consider how much Excess Capacity the Town wants to use. There is currently \$1.1 million in Excess Levy Capacity.
- Another way to help reduce the budget gap is to reconsider our reserve funding policies per financial policies.
- There are no personnel expansion proposals.

• Consider Level Services vs. 2% Reductions Budget presented by Departments Review budget calendar and set SB schedule for review and recommendations

- o Kuklewicz states he would like to follow-up with the schools, the Police Department, the Airport, the Clean Water Facility, and the DPW budgets.
- o Lord suggests taking a couple of weeks to review where each department is proposing reductions.
- Gill-Montague Regional School District has volunteered to host their Annual Budget meeting on Thursday, February 5 at the Gill Town Hall.
