The hearing on this Special Permit was opened on January 10, 2024 and closed on January 10, 2024.

#### **THE BOARD OF APPEALS VOTED:**

The Montague Zoning Board of Appeals granted a Special Permit 4 Yes to **John Benedict** to allow the replacement of 2 pre-existing, non-conforming illuminated signs, including a 4-ft by 13-ft building wall sign and a 1-ft by 6-ft free standing sign, under Sections 7.1.4, 7.1.6, 7.1.7(c) and 9.2 of the Zoning Bylaw, located at **187 Avenue A (Map 03, Lot 034)**, **Central Business (CB)** Zoning District, with the following condition:

- 1. Current signs and proposed signs do not negatively affect the aesthetics of the neighborhood.
- 2. Forcing applicant to change sign frame sizes would place an unnecessary burden on him.
- 3. Any proposed modifications to the approved final plans, including but not limited to changes, alterations, or expansions shall be reviewed and approved by the Zoning Board of Appeals, in accordance with Section 9.2.5 of the Zoning Bylaw.
