
## Executive Session Minutes Town of Montague Assessors' Department

## Abatements

- Parcel Id 53-0-061, 155 East Chestnut Hill Road Ms. Miller explained to the board about the research she did for the Town Planner when he questioned her, on behalf of a group of people, regarding valuation for underserved areas of town. The planner had provided a map indicating the areas of town which do not have access to high speed internet. Most of those properties are in the Rural Average neighborhood (NB) code and the one street that was in the Rural Good NB code is going to be getting cable soon. The reduced land value of the Rural Average NB code accounts for the reduction in market value due to not having access to high speed internet.
  - Motion made by Ms. Waidlich to deny. Second by Ms. Miner, vote unanimous.
- Parcel Id 06-0-001, 77 Eleventh Street— Ms. Miller visited the property, which is currently vacant and changed the building type from Lodge (which was based on a prior use) to Garage which is the most likely use of the property and added office space to the sub area detail. She also changed the grade of the bathroom and removed the fence from the yard items. Motion made by Ms. Waidlich to abate \$21,000 from the original value of \$109,600 making the adjusted value \$88,600. Second by Ms. Miner, vote unanimous.
- The following abatements were all based on changes which were picked up during cyclical inspections. Ms. Arruda notified the owners that the valuation would decrease based on the inspection and informed them that they could file for an abatement.
