Faith Adams - Salvation Army Request to Ring the "Red Kettle"

I'm the Volunteer Coordinator for the Salvation Army in Montague and we're raising money for the Red Kettle which all the money goes back to Montague citizens. I would like the Board if we can get a permit to ring tomorrow, election day at either Hillcrest Elementary School or at the Senior Center between 8:00 a.m. and 1:00 p.m. We would also like to ring on Avenue A during November and December. The Board felt that it was not appropriate to be done during voting, added congestion would be counter productive.

Town Administrator Report

Presentation on Performance Contracting by Roland Butze, Siemens Building Technologies, Inc.

Abbondanzio: Mr. Butzke is here from Siemens Building Technologies to talk about a project we have ongoing through the FRCOG to identify energy savings and potentially same some money down the road in town buildings.

Butzke: Performance Contracting as Frank introduced gives us an opportunity to find energy savings and improve infulstructure, it is a process that has been in place for a number of years, a number of communities have taken advantage of this in the Commonwealth and New England. The FRCOG opportunity started with Bill Grand who had the vision to create an opportunity for all the FRCOG communities and Regional School Districts to get together and provide an economy scale for energy service companies and made it all happen and put the RFQ out. He has since retired and Bob Dean took over the project and has seen it though to fruition. There was an RFQ done and Siemens won it. This is a straight forward concept, there is energy savings within the existing infulstructure. There is technology improvements that provide that energy savings; there is outdated infulstructure where the capital may not be available to make the improvements, the energy service company comes in and breaks that cycle. We put the newer technology in or refine the existing technology and therefore get the energy savings for it. The energy savings is used to pay for those upgrades and any residual energy savings in the community. Butzke goes over handout (see attached). Performance Contracting provides energy efficient upgrades at no up front costs. The Preliminary evaluation should be done and the board will gather more information as we go along. There will be a follow up meeting after the preliminary audit which is done at no charge. Once they are on site the report would be done in 30 days.

Pole Location Hearing - Pole to provide electric service to new public safety facility on Turnpike Road. Pat Kabera, WMECO: We are requesting permission to set a new pole between 2 existing poles to provide service for the Montague Safety Complex.

Zukowski does not feel late openings are a good thing, it just rushes people into Town from other bars to get their last drink. We don't have the staffing to support this. This would set a precedence. He does not have a problem with the bars staying open until 2:00 AM on New Years Eve.

Pruitt makes the motion to continue the present policy of not serving alcohol after 1:00 A.M except that New Years Eve is the only time bars can stay open until 2:00 AM. Seconded by Allen, approved unanimously. Allen – Aye, Ross – Aye, Pruitt - Aye

Abbondanzio: DCR informed the Town we did not receive the Heritage Landscape Inventory Program Grant. There were 18 municipalities that applied, and they gave 11 grants. There was a statement listed on how we can improve the grant.

A couple of months ago we requested a determination from the State Auditors Office, Division of Local Mandates asking whether Section 16B was a 1/12 budget process which resulted in the District Budget we presently cannot afford violated provisions of the local mandate law, Chapter 29, Section 27C. We also met with representatives of the Local Mandate Division

in Boston and basically what the division has decided is the local mandates law does not apply in this case because the costs at issue are the result of a local option law whereby the municipal members of a regional school district vote to accept and abide by the provisions of G.L. c71 \$\$16 - 16I and the specific regional school district agreement written for the communities joining a given district. By adopting the school district law, Chapter 71 we bought into any changes in that law.

Allen feels what ever can be done to bring this information to the State needs to be done.

Allen: I received a form letter from the Franklin Regional Planning Board asking that if I couldn't attend meetings could we appoint someone else. I would like suggest we ask the Planning Board if there is someone who could go.

Allen: Congratulations to Robin Sherman for her new position as Executive Director at the Franklin County Regional Housing Authority.
