# Robert Trombley, WPCF Superintendent Pine Trees along Greenfield Road

Trombley: When the WPCF was built back in the 80's a number of plantings were put in to try and cover the plant and provide a visual barrier. Over the years the trees have gotten bigger and because they are running parallel to Greenfield Road they have the tendency to block out the sun from to the east side causing the ice and snow to stay longer on the road and be more of an issue. The homeowners across the street from the plant sent a letter about the trees that have grown over the road. I have talked to Mark Stevens, tree warden and Tom Bergeron and Dan Laroche and there don't seem to be any major issues to take the trees down. I would like to have 17 trees removed and the cost would be \$1,600; I have this money available in my budget for ground maintenance.

Allen stated how there is always a lot of ice in that area.

Don McKay states how dangerous the area is due to the ice build up

Abbondanzio: The only issue I had was the stabilization of that bank leaving the roots in place and eventually replacing them with other plantings at a later date.

Trombley: Dan Laroche originally had concerns about that and he has talked to the Chair of the Con Com and they don't have any problems at this point. The trees will be cut level with the ground and we will plant low lying plants at a later date.

Pruitt makes the motion to advise the tree warden to proceed with taking down the 17 pine trees at the WPCF so as to make the road clear for sunlight and safety reasons. Seconded by Allen, approved unanimously. Allen - Aye, Pruitt - Aye, Ross - Aye

### Personnel

Trombley: The lead operator has handed in his retirement papers and Feb. 17 will be his last day. I would like to post for an operator in house for 3 days per the union contract, before going to the outside.

Allen thanks Mr. Andrews for his years of service; knowledge and expertise that has helped keep the plant moving along.

We are down to one pager, which will save us \$5,000 - \$6,000 a year. We have 2 people working 6:00 AM - 2:00 PM, and 2 people working 7:00 AM to 3:00 PM, which gives us 9 hours of coverage during the day.

#### Budget

Abbondanzio: I attended the Mass. Mutual Assoc. annual workshop on Friday and received the bad news which has already been in the paper. We wont know the final numbers until this Wednesday when the Governor presents his budget and the Department of Revenue will send out the preliminary cherry sheets Wednesday afternoon. At this point, we know there will be a mid year cut around \$150,000 and an additional cut in FY2010 anywhere from \$100,000 up. The FY2010 cut will depend on whether the state legislature passes legislation that would raise the hotel/motel and restaurant meal tax to generate some revenue that would mitigate that cut to some extent. I have heard that no town will be hit with more then a 10% cut in the second year. In any case it is a minimum of a 1/4 million dollars in cuts. Based on that projection, the Town Accountant has run some numbers and we are looking at a deficit right now, including special articles and including not using any of our reserves, looking at a deficit that is iust in excess of a million dollars. We have a lot of work to do to deal with the deficit in the current year, but also a very large deficit next year. President Obama's economic stimulus package is looking to be somewhere around \$830 billion last I heard and we should be hearing soon on just how that will be effecting the town individually. We were asked to come up with a wish list, we came up with 5 projects for that list. One of the good things coming out of the Governors budget is that Chapter 70 for the schools won't be cut this year, but that is not to say that something else won't be cut. On the municipal side, we got hit very hard, but on the educational side they are trying to prevent those kinds of cuts.

# Winrock International – Colle Building Lease

Abbondanzio: I have a letter from Winrock International, a tenant in the Colle Opera House Building giving their 90 day notice that they will be leaving. I have had a meeting with them and with the Northeast Foundation for Children who have a right of first refusal for the space and they are interested in leasing the space Winrock is in. Lease changes will be coming forward shortly.

# APR Announcement (Assessors Map 39, Lot 35 & Lot 47 and Map 42 Lot 8 on Meadow Road owned by Lena Garbiel)

I have a letter from the Dept. of Agricultural Resources and Mass. General Laws Chapter 7, section 41 requires that the DAR notify the Board of Selectmen of the States intent to purchase, rent, sell or change the use of one or more acres of real estate in a municipality and here we're dealing with 110 acres of land within the Town of Montague for inclusion in the States agricultural preservation restriction program (APR). The property in question (Assessors Map 39, Lot 35 & Lot 47 and Map 42 Lot 8 on Meadow Road owned by Lena Garbiel) and is privately owned and will remain so if it becomes a participant in the APR. The Conservation Commission has made a decision to use \$15,000 from the Conservation fund towards that. Certainly the State would expect more, but they know we have a limited amount of money available in that pool and there are other APR properties we want. I will forward this on to the Planning Board

#### Other

Mark Cannon asked the Selectboard on their position regarding the tomahawk chop gesture and why nobody is trying to change the name of Turners Falls.

Ross feels it is a subject of concern to a lot of residents on both sides of the issue but to have a full fledge debate on this now without preparation or notification is not the time.
