Approve minutes of October 5, 2009

Deb Bourbeau, Town Clerk, Request a polling change for precinct 6 (continuation from 10/5/09)

Bourbeau hands out report that the Town was written up for the Masonic Lodge regarding access for the elderly and physically disabled. The Town has to be in compliance, it's not that I want to move precinct 6 out of its elements and the comfort ability factor of the residents that vote there; we're mandated, we are supposed to find the most and best place for our residents to vote, all residents. If we want to stay there the Town is going to have to step up and fix it and spend some money.

Allen: Being someone who not only votes in Precinct 6, but works the polls, I think it would be a great idea to move.

Pruitt received a phone call today from someone who votes there and she felt it would be a great improvement to go to the new Police Station.

Abbondanzio: As ADA Coordinator I want to weigh in and say the handicap accessibility issues out weigh other factors, it's a compliance issue waiting to happen.

Fairbrother is against the move on principle but in view of the report doesn't see where he has a choice.

Extend temporary borrowing 2 months and looking to meet with Standard & Poor to talk financial conditions to hopefully upgrade bonds to get a better rate for borrowing. It would mean better rates on our permanent financing.

Fairbrother makes the motion to approve the sale of a \$5,095,475 at 2.25 percent General Obligation Bond Anticipation Note (the "Note") of the town dated October 23, 2009, and payable December 23, 2009, to Eastern Bank at par and accrued interest, if any, plus a premium of \$8,492.46. Permission to Conduct Research on Town Land, just South of Transfer Station Proposed Hydrology and Soils Study

This is a request from Deb Picking who is on the Conservation Board and she is asking permission to conduct research on Town land for the questionable possible vernal pool located on the landfill site. They study is a hydrology and soil study that is part of larger work that is being done as part of a larger Southern New England study. The research will not be used to certify that as a vernal pool.

Allen makes the motion to grant Deborah J. Picking permission to conduct research on Town land just South of the Transfer Station which is the site expected to be a vernal pool as indicated on her two aerial maps provided the town receives a report of her findings and the request goes through November 2011. Approve Policy for Placing Objects for Sale in a Public Way

Allen has received some complaints about businesses having paper signs in the windows and people having stuff out constantly along Avenue A. Thinks other Towns should be asked about their sidewalk policies.

Fairbrother doesn't think he wants to do this at all. Is not so sure this is a great thing or how good it looks.

Pruitt: I am aware of outside seating for the restaurants on the Avenue.

More research is needed on policy and will be looked at again before April 1, 2010.

Energy Performance Contracting

The Energy Task Force will be meeting on Wednesday at 4:00 PM and Siemens will be there as well as the Energy Committee. There are a lot of decisions to make a lot of which have to do with timing. We're at the point now that we are ready to do the investment grade audit, but unfortunately to do that we need to have an appropriation in place or account we could draw down from to pledge in case we don't go ahead with the recommended work included in the investment grade audit. Since this is not in place we have a little bit of an issue. I talked to him today about doing a memorandum of understand instead of a contract but they can't do that. They don't know if they can get all of the work done in time enough to satisfy the Dept. of Energy. The requirements set by state are very rigid. We will hear more on Wednesday, but it doesn't sound real promising. The grants that are available under the Energy Efficiency Block Grant Program are due on December 7th and are up to \$150,000 per community.
