Janke: Is looking for information on the upcoming meeting regarding the construction of the Gill Montague Bridge and is curious how the meeting was arranged because he and Pam Kostanski have been in close contact with Rep Kulik's office who knew nothing of the meeting.

Abbondanzio: Heard about it from Tom Bergeron who was approached about it by the contractor. The contractor was floating a trial balloon and asked for a meeting to make a proposal to see if we would be interested in the idea of speeding up the project in terms of the time of completion doing it in 2 years verses 3 or 4 by closing the bridge for two years. My immediate reaction to Tom was, it is never going to work because when we did this back in the late 80's the businesses downtown were seriously impacted. I am prepared to go to the meeting on Wednesday and say how I am against it. I think the contractor wanted to see if there was any support for it or not. The contractor was going to have to go back to the State through Mass. Highway anyway and they may not have been keen on the idea anyways.

Janke just wanted to voice his opinion on the way it was handled, not to blame anyone at the table.

Discussion about bridge repair, traffic

Janke: How substantially is the physical appearance of the bridge going to change?

Abbondanzio: My understanding is it is a historic bridge and shouldn't change much. The town has not been involved in a lot of these plans. Doesn't think Mass Highway will overrule Board of Selectmen on traffic flow.

Fairbrother: We will advocate as strongly as we can to keep the downtown impact as little as possible, while having to realize on the other hand there is going to be some unavoidable serious physical impacts on that bridge that have to happen.
