Allen and Fairbrother welcomes Chris Boutwell to the Board of Selectmen

Reorganization of Board of Selectmen

Fairbrother moves to nominate Patricia Allen as Chair of the Board of Selectmen. Seconded by Boutwell, approved unanimously. Fairbrother – Aye, Boutwell – Aye, Allen - Aye

Bob Trombley, WPCF Superintendent and Paul Gilbert, CDM **CSO Update – Fournier Press & Garage Extension**

Trombley: Here to discuss the continuation of the combined sewer overflow project. The addition/upgrade of the sludge handling system at the plant. We thought it would be a good idea to move forward since the STAG grant was available. We have written approval from the Department of Environmental Protection, USDA has been satisfied by the Town's attorney about the sole source procurement issue for the Fournier rotary press. We now have a revised probable cost and there were some concerns along the way that we didn't have enough money even with the STAG grant. We've gone back and reviewed the entire original conceptual design and have revised that while maintaining the quality and goals of the project.

Gilbert: (Goes over summary of Rotary Press Estimates) We knew \$1.4 wouldn't work so we put our heads together and worked with the Fornier people who manufacture the machine and fortunately the machine can be purchased in various sizes, which is unusual for a piece of equipment like this. Based on our research, we were able to make an adjustment on the selection of the machine, we were able to shorten the garage a little bit and made other adjustments. We were able to trim the project by \$300,000, brining it to a revised cost of approximately \$1.1 million. We are requesting your approval tonight to move along to the next phase, which would be bidding. If bids come in under budget we can come back in for approval to purchase 1 or 2 more channels.

Fairbrother makes the motion to authorize bidding of the CSO contract #3 for the Fournier press and garage extension. Seconded by Boutwell, approved unanimously. Fairbrother – Aye, Boutwell – Aye, Allen – Aye.

Discussion about how the Fournier Press will benefit the WPCF

Gilbert: Would like to go to bid June 1 and advertise with bid openings July 15, review the bids and come back to the Board the beginning of August with a recommendation. We would like to see the garage addition done in the fall and the press installation done during the course of the winter.

Declare Surplus Equipment

Trombley: We are taking out the list of all the equipment the plant no longer has or operates and coincident with that is parts on the shelf. I will be back several times between now to the end of the year, with other lists to try and reap some economic benefit instead of recycling it.

Boutwell makes the motion to accept the surplus equipment list of May 17, 2010 from Bob Trombley, WPCF as presented. Seconded by Fairbrother, approved unanimously. Fairbrother – Aye, Boutwell – Aye, Allen – Aye Frank asks Bob about the I/I

Trombley: Every year we take a look at the plant flow here and in Erving and compare that to what the water meter says was received. The difference we say is inflow and infiltration.

Fairbrother makes the motion that the Board grant a permit for use of Montague Center Town Common to Olivia Sears of Dry Hill Road for the Montague Center Farmers' Market on Mondays from May 24 through October 25, 2010. Approve 2010 Community Needs Survey

Abbondanzio: This is to get your endorsement on a town wide community needs survey that is being done in conjunction with the 2010 Community Development Block Grant. Last summer there was talk that DHCD was looking for more community needs information and we did a rough survey. The feeling was that this year we should try and do a town wide survey, so the FCRHA has put together this survey instrument and they will take care of the distribution to all households in Montague. It will be paid for through Community Development Program Income money that they have at their end. This is a way to get the community to weigh in on the specific projects that are already on our community development strategy document (side 1) this year and our long term plan. On the back page is a list of all the possible ways you can spend social service money that is basically dictated by what the funding agency considers eligible.
