#### Allen makes announcements

Allen thanks the DPW, Dispatch, Police both Fire Districts, the Emergency Management Director, MEMA, Electric Utilities, Other tree removal companies, business owners and the citizens were all very patient and mostly had a good sense of humor even though they were working around the clock. It was a very prompt and appropriate response by everybody. It was nice to know that each department could be counted on to do what they needed to do without having to find out from anyone else.

Elliot: I brought this article forward and it is an effort by the Alliance for Peace and Justice in Northampton and the Alliance for Peace in Greenfield and a campaign that began in Maine to bring the war dollars home. This is part of an effort to advise our elected leaders in Congress.

Elliot reads petitioned article into the record and gives background information.

Allen has received calls and people feel that this would be better if the question was put on the Town ballot at an election.

Terry doesn't feel this would work as he is interested in a binding resolution. This is not to leave troops over there without funding, this is to bring troops home.

### **Town Administrators Report Recent Storm/State of Emergency**

Allen; Transfer station was left open so people could bring their brush in over the weekend. You can bring your brush in on Wednesdays from 7:00 AM to 2:30 PM or Saturdays from 7:00 AM to Noon

Allen: The Tree warden felt there were 5-10 trees that were heavily damaged and unsafe and he would like permission to take trees down without a hearing as it is a safety concern.

Fairbrother makes the motion to authorize the tree warden to go ahead and take down the 5-10 trees that he feels are a danger. The Board would like to see a list brought into the office before removal and that if a tree is in front of someone's house that the abutter be notified. Seconded by Boutwell, approved unanimously. Allen went around to businesses downtown over the weekend and was asked by the entertainment establishments if it would be possible to have seating outside while there was no power. I spoke to some people and we decided we would allow it because of the emergency situation and the problems for the downtown businesses that had entertainment and liquor license establishments could be out on the side walk provided of course they left space for pedestrian walkway and there be no music played outside and any music that was coming from within needed to be at a low level.

Fairbrother makes the motion to grant a permit to use Peskeompskut Park specifically the band shell and grounds in front of it to Hannah Peters and Leonard Doucette of M Street in Turners Falls for a wedding. The event will be August 7, 2010 from 11:30 AM – 1:00 PM prep and cleanup inclusive, the Chief of Police has signed off on the event and they have signed a release of liability with the Town.
