We are still hoping they will do the minimal paving that needs to be done around the foundation where they cut between the new wall and the chlorine loading dock (about a 3' wide space). We are working on the first application of the stag grant, \$944,000 this first application; it's been a hair puller because it seems like they change the information as we go. In one case they didn't want copies of the invoices then they did.

Update on R.R. Salvage Property (James Bent, David Jensen, Building Inspector)

Abbondanzio: As a reminder, we're talking about the status of the revised order issued by Building Inspector that was issued on June 7, 2010. Basically we're talking about the status of the compliance with the particular issue dealing with minimum requirements that have to be met by November 15, 2010 to stabilize the structure; including removing any hazardous materials in an acceptable manner, removing all remaining floor and floor assemblies from the 220 x 72, 4 story section of the building, salvaging, storing or disposing of the debris properly and clearing off the top of the exposed walls from potential falling loose bricks.

Jensen: We're progressing.

Jim Bent: I started pulling permits, and pulling permits you have to go through DEP, you have to have all the hazardous material removed before you can knock down any walls or the wall would have been done a long time before now. I had to go through DEP and they are kinda beating me up; I had to get some stuff I didn't have prepared for them, and the L part of the building still has asbestos in it and it has to be removed before we can knock down walls. I sent a crane in last year to knock down one side and they went crazy because it wasn't supposed to be done before we went through DEP. I'm not familiar with DEP laws, I'm from New York, and NY is totally different, we are learning as we are going. The permit from DEP should be in place by the end of the week. DEP wants the asbestos removed before taking walls down. DEP is slow.

Fairbrother wants the Select board to be informed once Bent has received the permit from DEP. Bent will let the Board know.

Bent: Asbestos should be gone in the next week or so, I've already hired a contractor to do it, but then I postponed him because I wanted to knock down the walls first. I have to go back the other way because he needs to give 15 days notification to DEP before they can go in and start it. He should be starting in another 4 - 5 days. Once the asbestos is removed we can go through the DEP permit to take the walls down. I don't see much getting done there except for the asbestos being removed; I'm just hoping it doesn't collapse. Whatever can get done we'll get done, once snow comes, I'm not putting guys in there. Cleaning up outside, hauling away trash and has security on site.

Board wants to be kept up to speed and told when the permits are approved.
