# Frank Abbondanzio, Sign Local Support Documentation Form for the Public Health District Incentive Grant Program

- Board of Health already signed off on this, Gina McNeeley is in favor of participating in the grant that will conduct a study to fund a Regional Health District.
- Study will run March through September and will be administered through the Franklin Regional Council of Governments, Phoebe Walker.
- Main reason of being part of this grant is a consultant will evaluate what the costs and benefits of being part of a district are with the advantage of the Town being a part of this.
- It looks as if it won't result in a lot of savings to the Town, but one of the main advantages is down the road especially, as we get more and more mandates the Board of Health will be better equipped to handle them because they will have the resources without having to hire new people at the Town level. A lot of money is spent by various towns on health services. There is a lot of duplication that can be eliminated.
- One issue in particular mentioned by McNeeley is the new mandate to be in charge of the landfill. If you have the entire region working together, you could hire someone who had expertise in that.

Fairbrother makes the motion to authorize the Chair to sign and submit the document to become a member of this planning grant proposal through the public health department. ### Adopt Inclement Weather Policy

Allen: I don't think we are quite ready to sign the document; after meeting with some of the Department Heads, was thinking we needed to add a sentence to the effect of department heads may elect to work if the building is closed, other employees may only work with department head approval.

Fairbrother and Boutwell are in agreement this needs to be added, but Boutwell thinks if the department head needs someone to come in to work, it should be passed on to Frank or the Board of Selectmen.

Allen proposes motion to add the following: Department Heads may elect to work if the building is closed, other employees may only work with department head approval and notification to the Town Administrator and/or Board of Selectmen.

Fairbrother would like to wait until the policy is updated before approving. Will be put on the next agenda.

- Presidents current budget proposes a 7.5% cut in the CDBG program. It will depend on how the State decides to allocate the cut.
- Allen agrees with Frank that FCHRA have done a great job, there are very few of their projects that Montague has not been involved in.

#### FRCOG – FY2012 Budget and Montague Assessment
