Robert Trombley, WPCF Superintendent, Change Order #2 – CSO & WPCF Upgrade - Rotary Press & Garage Extension

Trombley: This involves an addition to the coating system for the walls on the garage extension itself to the panels. The panels are hot dipped galvanized and I talked to the engineers whether or not that was enough for longevity given the environment it will be present it and the building because sludge that is going to be stored in the container will generate some gasses particularly hydrogen sulfide which in the presence of moisture produces sulfuric acid and loves to eat things up, especially metal. This is an attempt to provide a longer lasting product that will require less maintenance for a good number of years at the facility. There is money in the budget to cover this.

Abbondanzio: This is an application for a pilot program grant under the green communities act to implement a community wide solar photovoltaic program and up to 4 green communities will be chosen. Walter is working on this application. If awarded, the Mass Clean Energy Center will market the program locally and issue an RFP for the selection of at least 2 solar installation companies, (one offering a direct ownership model and one offering a leasing model for customers) to focus their efforts on aggregated purchasing of equipment for installations within the communities.

- I heard from Beth Greenblat and Siemens has been busy finalizing their calculations for energy savings, getting firm pricing from subs for Town Buildings and will be looking to have a project meeting during the last week in March. The work in regards to the school project may be a subsequent phase. We have until the end of June to put a boiler into this building but we might be able to get that extended until August.
- MMA Website indicates that the legislature has put the Towns on notice that the Governors budget might have been optimistic and we may see larger than a 7% cut; we budgeted for 10%. We are hoping to get some kind of resolution from the legislature telling us what the number is by the middle of April.
