Frank Abbondanzio, Town Administrators Report

Execute FY11 Engineering Agreement for Landfill Monitoring Services

Abbondanzio: This is an annual agreement; we did hold off this year on awarding the contract for the second half of the year because we thought the FCSWMD was going to be able to get a bid out for that, and it turns out to be more complicated than they thought, so they cannot do it this time around. Tighe and Bond needs to get started on that work to meet our annual monitoring requirements.

Boutwell makes the motion that the Board approve the agreement with Tighe and Bond as the FY11 Engineering Agreement Landfill Monitoring Services for the Town of Montague with the scope of the work as in the contract that is presented. Seconded by Fairbrother, approved unanimously. Boutwell – Aye, Fairbrother – Aye, Allen – Aye.

Donna Estabrooks, Jeri Case and Elma Kuklewicz, home owners near the Lake Pleasant Railroad Crossing, Noise and fumes from multiple train engines idling next to their homes for days and nights at a time

Abbondanzio moves into the audience because he is involved with this issue

Abbondanzio: Basically we've had a lot of complaints that have come in from both Lake Pleasant and Millers Falls to the Police Dept. and directly to the Selectmen's office about the trains that diesel, idle for hours at a time. I understand that in Lake Pleasant it has actually been 3 – 4 days at a time. There is a real concern about the air quality as well as the noise and the complaints don't seem to do a lot of good. The Chief promised to provide a history of all the complaints that have been made in the last 3 years. Tonight, we are asking to have a joint public hearing between the Selectboard and Board of Health and invite the appropriate people to attend that hearing including the residents from the neighborhood that have the issue with the Railroad over this dieseling, but also the regulatory agencies representatives from the Federal EPA and State DEP and also someone to give us legal advice on this. It is a situation that is going to come to ahead; the Board of Health has actually been involved in it already so there have been discussions between the Town and the Surface Transportation Board.

Gina McNeely: And the Railroad itself. PanAm, I've talked to their chief counsel , written letters since 2008 (has packets for everyone). Goes over recent response from the Railroad stating attitude of Railroad as far as being a well subtle law that operations of railroads fall under the "exclusive" jurisdiction of the Interstate Commerce Commission Termination Act of 1995 and the Federal Railway safety act; both of which preempt all local and/or state laws, regulations seeking to govern railroad operations.

Question regarding if they are exempt, why did the State go to all the trouble to make Railway laws?

Abbondanzio responds: This preemption thing goes back to 100 years ago when the railroads were instrumental in founding our country. I think the idea is to remove obstacles for that continued development and essentially I think that is how it is interpreted by the railroad. The State and local government are pretty much irrelevant in this case. The question is how can you totally disregard the Clean Air Act when people are being impacted by it. We have 30 selective signatures from Millers Falls and I know there are other signatures that have been gathered in Lake Pleasant, but the goal is to get a joint public hearing when people have the opportunity to speak and make their concerns known.

E. Kuklewicz: This has been ongoing for about 25 years, there are times in spring, summer or fall if you have your windows open you have turn your T.V. up as loud as it will go, the smell is terrible, there have been times the railroad has left a train parked running for 40 hours, a whole week during a strike they had, with nobody on it. Kids go down there and

play on it, I'm also concerned about the water supply of Lake Pleasant because if you walk down the tracks you will see where things have come out of the train, and eventually it is going to make it to the water supply.

?? The three of us all own houses right next to the crossing in Lake Pleasant; I had a painter at my house one summer and after a couple of days of it left during one of the 4 day stretches where the train was parked there and he had his radio up full blast and still couldn't stand it. I wear those things that jack hammerer's wear and I still can't sleep.

Discussion: The air breaks sound is deafening. When you hear a train you hold your breath that it is going to stop. Lengthy discussion about idling trains and where they are parking the trains, calls to train dispatchers, conflicting information that is given to residents. Discussion about what is considered "maintenance". It is not so much that the trains are running, it's just that they are running in the neighborhood. Trains should go to the train yard or where there is just woods. Supposedly the RR yard has been jammed up, that is why they are parking a mile up the tracks, because they can't get into the yard.

Abbondanzio: Several years ago there was a hearing with Guilford Railroad and I noticed there was a big change in terms of their policy towards dieseling for a while. Since PanAm has taken over it pretty much has gone back to the way it used to be years ago. We had Guilford Transportation in here, they met with the Board of Selectmen, they gave us personal numbers that we could them at home.

Kuklewicz: Since PanAm has taken over they go flying buy, I have stuff rattling and falling off the walls.

Allen: We are going to ask to have this joint public hearing, can you write down the specific issues, talk about the speed all the things. Maybe put it in priority of what we think we could effect for changes. Gina, can we ask that your department (you), work with Frank to get a joint public hearing as requested.

Kuklewicz: It's hard to have company over in the spring and summer, when you're sitting there having a cookout and have people over and all you can smell is the diesel and you get a headache from the train running.

Questions about whether someone could test the air quality. The Town does not have the equipment to do this, but Gina could ask around and possibly DEP would have air monitoring equipment and be able to go out when a train is dieseling or idling.

McNeely: I just want to say, when I started getting calls, I really thought I was going to get somewhere with the Railroad and it has just fallen flat. It is very frustrating.

Fairbrother: Those engines, as long as they are running no matter what they are doing, they are going to produce fumes, going down the tracks. At this point it is probably fairly quantifiable; I think the problem here isn't the fact that they are producing the fumes they will produce when they run, it's the fact that they are sitting in one place, running all the time. It probably wouldn't hurt if you could document how long a train is sitting there, from when to when.

Abbondanzio: The sad thing is the technology is there for much lower emissions and that is what EPA is trying to get the Railroad to do, to implement this. A lot of the engines are 50 years old, and they are retrofitting them really slowly. Suggests mapping out areas where there are clusters of neighborhoods, and where the areas are that are in the boondocks that are away from where people live.

The plan is to have a public hearing scheduled within a month
