Don Clegg, Registration for Assembly, Public Demonstration, or Use of Public Property: Great Falls Farmers Market

Town Administrators Report Review Proposed Precinct Map

Abbondanzio: Deb has asked me to explain what tonight is all about. It is not to get you to vote on the map, basically she wants to know if the Selectmen like the map and if you do, she will go back to the Secretary of States Office and they will make the appropriate changes and divide the legal descriptions that you need and then you can vote on those. This map addresses the concern about villages being split in half.

Allen commented that the map looks much more like we were hoping it would be, as well as Boutwell. Fairbrother would just as well stay with 6, but that's a done deal. If you're going with three this is much better.

Frank Abbondanzio, Town Administrators Report

Gill-Montague Bridge Lights

Abbondanzio: This has to do with the lights on the G/M Bridge and who pays for them. The issue is not resolved at this point; I have been in touch with WMECO and the legislatures. Firstlight gave me a cost estimate; there are 54 lights, 27 on either side that will replace 8 lights that are currently on the bridge. Currently the Town pays for 5 lights through the

Turners Falls Fire District and Gill pays for 3. We currently pay \$1500 a year on an unmetered rate. WMECO owns and maintains the lights and each town pays the delivery rental charge and the current energy supplier cost. The new lights are a different story; they are not going to be owned by the Utilities, we are no longer leasing lights they are part of the bridge so the bill goes to the owner of the bridge. Right now the owner is the Commonwealth as that bridge has been laid out as a state highway in 2008 in anticipation of the project. The question is what happens when the project is completed? The argument we are trying to make is that this bridge is no different than Sunderlands where the State pays for the lights. Based on the anticipated usage we are expecting \$5,000 a year just for energy costs, in addition since the lights are not owned by the utilities, someone has to also pay for the cost of maintaining the fixtures, the cost of replacing light bulbs which have not been calculated yet. It is to our advantage to make sure the State ends up the one who pays the bills in the end. If we are responsible to pay bill, maybe you don't have 54 lights on at one time. We did not have a whole lot of input in the design of this plan. It has been put on record with the State that we don't feel we should be responsible for paying this. Ray Purrington from Gill has also brought this forward as well as the Turners Falls Water and Lighting District.

Vote on Article 29, "Unregistered Motor Vehicles"

Abbondanzio: After back and forth with staff and Town Counsel it was recommended that the Selectmen recommend a negative vote and bring it back later. The motion to go before the Town Meeting members is so different that it would be confusing. Not a lot of changes in substance but it would be difficult to follow the discussion.

Fairbrother makes the motion that the Board recommend to Town Meeting that we would like a no vote on Article 29, Unregistered Motor Vehicles. Seconded by Boutwell, approved unanimously. Fairbrother – Aye, Boutwell – Aye, Allen - Aye

Vote on Declaring Montague Center School Property as Surplus

Fairbrother makes the motion that the Board of Selectmen vote to declare the property known as the Montague Center School surplus and available for disposition in accordance with the provisions of MGL Chapter 30B, Section 16. Seconded by Boutwell, approved unanimously. Fairbrother – Aye, Boutwell – Aye, Allen - Aye

Fairbrother makes the motion that the Board of Selectmen authorize the Montague Capital Improvements Committee to issue a Request for Proposals for the disposition of the Montague Center School property. Seconded by Boutwell, approved unanimously. Fairbrother – Aye, Boutwell – Aye, Allen - Aye

Fairbrother makes the motion that the Board of Selectmen, as a condition of any sale of the Montague Center School Property to a non-profit organization, make provisions in the purchase and sales agreement requiring said non-profit organization to make annual payments equivalent to any taxes that would otherwise be paid to the town by any other owners. Abbondanzio: I went through the RFP and have tried to simplify it a little bit. There is not a lot of changes that I'll be proposing the Capital Improvements Committee.

Response to Open Meeting Complaint from Peter Golrick

Abbondanzio: Two major issues brought up by Mr. Golrick and the letter addresses both of them. 1) That members of the By-law committee hadn't been sworn in 2) the new committee must appoint a clerk to manage the records. Response to letter is that the Board of Selectmen do not believe they have committed a violation of the open meeting law or public records law. The By-law review committee is a special purpose study committee apprised entirely of Town Staff, all individuals appointed to this committee have already been sworn to office in their capacity as appointed or elected public official. The committee is not a subcommittee of the Board of Selectmen or any other public body that would trigger the open meeting law. Meetings of the committee are staff meetings and the actions are purely advisory in nature and are made only in support of policy making decisions by the Board of Selectmen.
