Presentation of Petition by David Detmold

Detmold: I live at 60 Fourth St. and I want to present this petition to the Selectboard and hopefully it can be scheduled for discussion at an upcoming meeting that we could invite either Chief Zukowski or someone from the Police Department to help us with this problem. We have 15 signatures on this petition of people who live immediately next to us and business owners who operate businesses directly near our corner of Fourth Street and Avenue A. The problem we're having is a problem of a certain apartment where a group of people for the last several years has been using their stoop as a public drinking place and carrying on a loud and boisterous conversations and swearing with the worst kind of profanity until 3:00 or 4:00 in the morning, night after night, week after week, year after year. We and the other neighbors have called the police on these people and the problem just continues to persist. We cannot get sleep, there are young children being raised in the neighborhood who are listening to the worst kind of profanity. At some point, I would think, with Chief Zukowski's help, we ought to be able to enforce the Town's by-laws about being able to enjoy peace and quiet in our homes at a certain hour of the evening. This is an ongoing problem, we don't like to bring this to your attention but have just been unable to solve it as a neighborhood, or even with the help of the police, with us calling the police. We are turning to the Selectboard to see if there is anything else that can be done.

• Fairbrother: I received a call from a resident who was curious because he was receiving automatic updates on the situation over the weekend from Erving and another Town and he was wondering why he was not getting any of those from Montague?

Allen: I got a call from WMECO as I suspect most people did. As for the Town of Montague, at 9:00 AM we met with all of the Emergency Management folks, Board of Health, Police, Fire, DPW, WPCF, both Water Districts, and the School. Everyone was well mobilized and reported on how they had prepared, how they had arranged for staff, everyone was coordinating very well between them. At noon we recognized that we were probably not going to have anything to severe. This year we are part of the regional consortion and the emergency shelter for the last event was here in Turners Falls High School so this event it was going to be at the Greenfield Middle School. We opened the High School for some folks at the Arbors in Greenfield. All the groups did a wonderful job.
