Natural Hazard Mitigation Grant Application: Millers Falls road Soil Stabilization

Ramsey: Montague DPW had initially approached my office last year to seek FEMA/MEMA funding to stabilize this failing bank near Cemetery Rd. Since then, the Town has completed a Natural Hazard Mitigation Plan and this mitigation project has been engineered by Milone + Macbroom through a regional grant. The Hazard Mitigation grant application (due 11/4) has been prepared by FRCOG. Through a detailed calculation it has been determined that the benefits of doing this project prior to bank failure outweigh the costs of a post-disaster repair. For the purposes of the grant application I am requesting a letter from the Board of Selectmen to A) support the project and B) request the project's 20% municipal match (\$77,000) at the next Town Meeting This was discussed with the Board a couple of months ago.

Allen makes the motion to approve and sign the letter to Scott MacLeod Coordinator of the Hazard Mitigation Grants of MEMA in support of the Hazard Mitigation Grant Application: Millers Falls Road Soil Stabilization request and we go to town meeting to request approval of the appropriation to cover the Towns cost on that.

Execute DHCED Peer-to-Peer Grant Contract

This 100% reimbursable grant from Department of Housing and Community Development will allow a preapproved consultant to commit \$1000 worth of services to expand The Town's Municipal Geographic Information System which is being developed in the Planning and Conservation Department. Work to be done this Winter and Spring.

Turnpike Road Energy Park Landfill Solar PV Update

The RFP consultant Selection committee has received bids from both RFPs and is in the review process. The Town received 6 proposals to conduct master planning of the area. The committee expect to have a final recommendation to the board for next week's meeting. The Town has received 4 Solar PV proposals for the capped landfill. The system would range between 1 and 1.3 MW. The committee will evaluate responses based on technical merits, firm success rates, and the economic benefit proposed to the Town. The committee is scheduled to make a recommendation for the Nov 14 BOS meeting.
