Public Hearing:

Robert Trombley, WPCF Superintendent, Change in Septage Rate

Trombley: Last week I appeared before you to discuss the sewer septage rates and I requested having a public hearing to allow me to adjust the rates between \$75/per 1,000 gallons and \$95/per 1,000 gallons and maintaining the in town rate at a lower rate at all times. The in town rate also includes the Town of Gill by inter-municipal agreement. I would be looking at starting at \$75/1000 gallons in town and \$80/1000 gallons out of town effective tomorrow. At any time we can stop receiving septage depending on what's going on and we can limit septage haulers to x number of gallons per day, which we have done in the past. No issues as long as we treat all of them the same.

Allen makes the motion to authorize Bob Trombley to use \$75/per 1,000 gallons as the in town rate as well as the Town of Gill and \$80/per 1,000 gallons for the out of town rate with the ability to adjust those rates if necessary with discussions with Town administrator or Board of Selectmen, this shall be in effect until the next sewer rate hearing. Seconded by Boutwell approved unanimously. Allen – Aye, Boutwell – Aye, Fairbrother - Aye

D. Detmold asks if we expect to make more money doing this? Trombley responds that this is what we are about to find out. The winter time is the slow time. It's an attempt to see how much septage we can bring into the facility and help us with the process and we also found the septage helps us in dewatering the sludge to a higher percent solids.
