## Acting Police Chief Williams – Request for one full-time officer

Williams: When the Board was going to request a statewide list for Chief we were going to go with a temporary full time guy until the position was filled, but now that the test is going to be solely for the Montague Police Department and available to everyone on the force, I'm confident the Chief will come from the Town of Montague and therefore requesting to fill the temporary full time position with a permanent full time patrolman. This would replace Ray as a body.

Allen: I wouldn't dare do that. I'm assuming that at least two people will pass the test, but if by some odd chance that did not happen, then we might find ourselves in the position of having an extra police man on hand. I personally don't think we can do that. If no one passes it, then we have to start over.

## Authorize Chairman of Board of Selectmen to sign Downtown Initiatives Grant Application

Lisa Davol: We just found out about this grant, and I'm going to scramble to write it by Friday. Basically it's for money for a consultant that Downtown Initiatives added a creative economy section to what they fund and we are requesting money for a consultant to help us identify programming that will have a greater impact and looking at our history and what we've done. It can't hurt to have some help in that area. They don't give us money directly; they take the money and hire a consultant.

## Landfill Solar RFP – Sign proposal rejection letters

Pat Allen recuses herself from this discussion as she is an abutter

Ramsey: The Town has received RFP's for solar development at the Landfill and they have been reviewed by an ad-hoc group made up of the Town Administrator, Town Planer, and representatives of the Energy Committee, Capital Improvements Committee, as well as the TF Water Dept. and WPCF. Unfortunately of the four proposals that came in, none of them are financially advantageous to the Town at this point. They all looked like they were technically feasible projects to do solar on the landfill but the economics just don't work out in favor of the Town. I am requesting that the Chair make a motion to send letters of denial to the applicants that submitted the RFP's. We are still looking at ways that we can make a project on the capped landfill viable as far as solar.

Boutwell makes the motion that the Board reject all four proposals for the RFP for the Solar Landfill and issue letters to that effect. Seconded by Fairbrother, approved. Boutwell – Aye, Fairbrother – Aye, Allen – Abstained from meeting

### Other

A planning consultant, The Cecil Group is looking at the Industrial area around the landfill and they are well under way on that project. There is going to be a public meeting on January 31, 2012 at 6:30 at the Public Safety Complex. This will be to get public input and they are going to present the preliminary design and conceptual vision of what that site could be used for.

Allen rejoins meeting

Allen makes the motion to go into executive session for purposes of litigation and only come out to adjourn the meeting. Seconded by Boutwell, approved unanimously. Allen – Aye, Boutwell – Aye, Fairbrother - Aye
