Fairbrother announces meeting is being taped

Approve Minutes of March 5, 2012 if available; votes may be taken

Boutwell makes the motion to approve the meeting minutes of March 5, 2012. Seconded by Fairbrother, approved unanimously. Boutwell – Aye, Fairbrother - Aye

Bruce Hunter, FCRHRA and Jon Dobosz, Director Parks & Recreation, Award Unity Park Phase One Construction Contract

Abbondanzio: We are delaying this bid as it needs to be reviewed with counsel.

Montague Agricultural Commission – Right to Farm By-Law, votes may be taken; Donna Francis, Bob Mizula, Diane Flynn, Walter Ramsey

Francis: The Right to Farm By-Law is really a restatement of the Right to Farm supported by all citizens of the Commonwealth. One of the purposes of it is to show our support for farming in the community and recognize the importance of agriculture to the community both economically and socially and preserving open space and so forth. One thing it does not do is change any of the zoning regulations or the existing laws. It doesn't give farmers any new rights (or relieve them from any responsibilities) that they don't already have under the Mass. General Laws. Why do we need this by-law? In addition to affirming the Towns support for agriculture, it establishes an avenue for informing new residents that they are moving to an agricultural community, and it is a place where you might expect to have some odors, noises and maybe some inconveniences associated with normal farming practices (slow moving vehicles, and that sort of thing). The disclosure notification section addresses that and requests that the Town inform buyers and renters that they will be moving to this farming community and to expect some of these kind of things. It also establishes the Agricultural Commission (AC) as potential help with resolving disputes between farmers and neighbors that might have a complaint about normal farming practices. Another advantage of having this in place is the Town will receive a decrease in APR costs.

Ramsey: The advantage is when a resident wants to put land into APR the Town is required to do a match, when people want to protect their land in perpetuity the Town typically contributes a match to purchase those development rights that remain farmland. They match is typically 20% and if the Town has a Right to Farm Bylaw, then that is reduced by 5%, so the Town's match is then 15%; and also having an AC reduces it another 5% so now it's down to 10%. We are working on some other initiatives to reduce that even further. In a way the Town is contributing towards agriculture preservation without actually spending money. We are well on our way of meeting the objectives on the 2010 Open Space Plan.

Boutwell: I received a call from Gina McNeely, Director of Health and I understand there have been some dialog regarding some things in here and she told me she does not like it the way it is written at present time. I've noticed one of the things that has been changed since the original draft; If a person puts in a complaint to the Town Administrator, Selectboard or the Agricultural Commission none of those have any clout to do anything about it. The only one that has any clout to act on the problem is actually the Board of Health when it comes to nuisances, odors, dust all that. The BOH has the statutory power to do that. The other issue refers to activities that cause noise, dust and odors and can occur by day or night, on weekends, weekdays, holidays occupying land within the Town of Montague which means should expect and accept such conditions as normal and necessary aspect of living in such an area.

Flynn: This doesn't really change anything that has been happening right along. This is just regular farming in Montague, this explains to people that if they are moving to the area, we are a farming community.

Ramsey addresses Boutwells concerns and explains that it said originally any disputes involving those will go to the Agriculture Commission to be decided but they realized that oversteps the Public Healths authority and now we say

they would have the option of sending an issue to the Agriculture Commission, if they think it is an issue that the farming community could weigh in on. They have valuable insight because they know farming in the business better than just about anybody. It is just an option the BOH would have, I see that as an asset.

Francis: A person who wants to complain, might not know that they should go to the BOH, they might go to the Selectmen first, then you would send it to the BOH or call us in as well. I tried to get everyone in there who might be contacted..

Zula: Nothing supersedes anyone's authority; it's a way for the complainer or dispute resolution in something there doesn't rise to an enforcement action.

Francis: Will be educating people before Town Meeting on this. Town Meeting has to approve then it will go to the Attorney General's Office for final approval. This bylaw will be available at Town Hall, put on the website and we will be requesting that people selling or renting land be given to the new person.

Jensen expresses his concerns which were addressed before he arrived at the meeting. Downside to farming is pesticides and handling of animal manure, all of which have had serious environmental effects, these are significant environmental considerations. This bylaw essentially states that manure, fertilizer and pesticide handling is beyond the control, it is according to whatever federal regulations there are, which are generally what the manufacturer says it can be used for. Pretty much any amounts that the farmer deems necessary, no local control. Fertilizer also, over application of fertilizer will now be, according to this, a protected right and also...

Fairbrother stops Jensen from talking. As we said earlier, this bylaw doesn't change compliance with any State, Federal or local laws regarding anything. It is not like farmers are being given a new right in Montague with chemicals, manure, loud noises or what have you. It doesn't give them any new right, id doesn't relieve them of any responsibilities whatsoever. Basically all it says, is farming does have certain byproducts, sound and what not that can happen at any time that some people might not like. This allows a farmer to continue to run his or her farm the way they have been running it as long as they are in compliance with all applicable regulations.

Abbondanzio: There is still best management practices, and they have been in existence for decades and the regulations are very strict. A lot of what David referred to were at a time when a lot of those regulations were not in effect and the EPA was concentrating more on points source.

Further discussion. Does not apply to just existing farms, no size restrictions (small or large)

Boutwell makes the motion to authorize the Agricultural Commission to put a Right to Farming By-law on the Montague Annual Town Meeting warrant. Seconded by Fairbrother, approved. Boutwell – Aye, Fairbrother - Aye
