GREETING:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the Inhabitants of the Town of Montague qualified to vote in Town affairs to meet in the Turners Falls High School Theater on Wednesday, April 4, 2012, at 7:00 P.M. and to act on the following articles and any motions which may be presented.

**ARTICLE 1.** To see if the Town will vote to raise and appropriate, transfer from available funds, borrow or otherwise provide the sum of \$3,331, or any other amount, for the purpose of paying costs associated with the settlement of the Fiscal Year 2012 collective bargaining agreement with the TOMEA union, or to pass any vote or votes in relation thereto.

(Board of Selectmen Request)

**ARTICLE 2.** To see if the town will vote to raise and appropriate, transfer from available funds, borrow or otherwise provide the sum of \$1,908, or any other amount, for the purpose of paying wage increases for non-union employees for Fiscal Year 2012 consistent with the new contract for the Town of Montague Employee Association, or to pass any vote or votes in relation thereto.

**ARTICLE 3.** To see if the Town will vote to raise and appropriate, transfer from available funds, borrow or otherwise provide the sum of \$30,000, or any other amount, for the purpose of paying for a town-wide pay and classification study, or to pass any vote or votes in relation thereto.

**ARTICLE 9.** To see if the town will vote to raise and appropriate, transfer from available funds, borrow or otherwise provide the sum of \$40,000.00, or any other amount, for the purpose of supplementing the Fiscal Year 2012 WPCF Budget appropriation, or to pass any vote or votes in relation thereto.
