**Special Town Meeting Warrant, September 10, 2012 – To approve and execute draft warrant** Allen makes the motion to approve **ARTICLE 1.** To see if the Town will vote to raise and appropriate, transfer from available funds, borrow or otherwise provide the sum of \$160,000, or any other amount, for the purpose of reducing sewer user rates for fiscal year 2013, or to pass any vote or votes in relation thereto. Seconded by Boutwell, approved unanimously. Allen – Aye, Boutwell – Aye, Fairbrother - Aye

Allen makes the motion to approve **ARTICLE 2.** To see if the Town will vote to change the funding source from sewer borrowing to retained earnings for Article #12 of the May 5, 2012 Annual Town Meeting which appropriated the sum of \$60,000 for the purpose of purchasing and installing a fourth dewatering zone on the Fournier Rotary Press, or to pass any vote or votes in relation thereto. Allen makes the motion to approve **ARTICLE 3.** To see if the Town will vote to rescind the remaining \$849,500 in borrowing authority on Article #6, voted at the June 9, 2005 Annual Town Meeting to fund the Combined Sewer Overflow Project, or to pass any vote or votes in relation thereto. Allen makes the motion to approve **ARTICLE 13.** To see if the Town will vote to authorize the Board of Selectmen to convey all or any portion of the parcel owned or to be acquired by the Town shown as "A Portion of Book 452 Page 248 (1896)" on a plan entitled "Land in Montague (Franklin Co.), MA Surveyed for St. Anne's Parochial School," dated March 2, 1999, recorded with the Franklin Registry of Deeds in Plan Book 128, Page 10, also known as the Rectory property or 25 Sixth Street in Turners Falls and identified on town assessors Map 03, Lot 022, acquired for general municipal purposes pursuant to the vote under Article 2 of the May 5, 2012 Special Town Meeting, by one or more conveyances, on such terms and conditions as deemed appropriate by the Board of Selectmen, which consideration may include acquisition of all or any portion of property shown as "Roman Catholic Bishop of Springfield," "St. Anne's Parochial School" or an alley called "A Portion of Book 452 Page 249 (1896)," and to authorize the Board of Select men to acquire all or any portion of said Roman Catholic Bishop of Springfield, St. Anne's Parochial School or alley property for general municipal purposes and for the purpose of conveyance, and to authorize the Selectmen to convey any or all of the property to be acquired pursuant to this vote, on such terms and conditions as the Selectmen deem appropriate, in accordance with General Laws Chapter 30B, Section 16 to the extent applicable, or pass any vote or votes in relation thereto. Seconded by Boutwell, approved unanimously. Allen – Aye, Boutwell – Aye, Fairbrother - Aye

Allen makes the motion to approve **ARTICLE 14.** To see if the Town will vote to establish a revolving fund for the remainder of fiscal year 2013 in accordance with MGL Chapter 44, Section 53E1/2 for the receipts related to the Town's recycling program and expenditures for the operation of the Town's solid waste and recycling programs, membership in and services of the Franklin County Solid Waste Management District, and the purchase of recycled content or environmentally preferable products, to be under the authority of the Board of Selectmen and not to exceed \$15,000 in expenditures in fiscal year 2013 or to pass any vote or votes in relation thereto.
