Peter Vichi, Shoulder Erosion, 11 Taylor Hill Road (Mr. Vichi did not attend)

Bergeron: Mr. Vichi came in 2004, requesting a driveway permit because he was going to build a house on Taylor Hill Road. As I always do, I have them mark out where the driveway is going to go and then I go and look to see if there are going to be any issues. This particular driveway because there was already a ditch line there, I requested on his permit that he install a 12 " culvert under his driveway to let the water continue to go through because it is quite a little incline there. A couple years ago I received a call from Mr. Vichi saying the rain washed out his driveway. Dick Clough and I went and up and spoke to him, mentioned he has not put the 12" culvert in like his permit requested, he said OK and I believe he agreed it had to be done. The permit requires the first 15' of the

driveway be paved from the road edge so it doesn't break up our roadways. I think back then I said he could put the culvert in at the end, it was never installed. He again called the office to say the heavy rains washed out through his driveway. Called Frank this summer with complaint of washout. Still no culvert installed, still not paved. Wanted us to fix it, I said we wouldn't fix it because he has not done what he needed to do according to the permit he had been given. There have been 2 - 12" culverts sitting in his driveway for 9 years and I keep mentioning for him to use one.

Abbondanzio: I also told him based on the facts Tom presented, that he need to correct the problem, but he didn't like that and wanted to meet with the Board.

Fairbrother: Drainage ditch or no drainage ditch, if he put the pipe in it would be a mute point.

Allen: It does point out that no one goes and checks that all the conditions have been met.

Jensen: There is an enforcement mechanism, unfortunately it's mine and it was an oversight on my part when the Certificate of occupancy was given. The building was started in 2004, it wasn't occupied until October 2010. With that occupancy, it was conditional and it listed a number of things, unfortunately it did not list the driveway was an issue. Since it had been in existence for a long time, it was not included. In 2011, Mr. Vichi requested a more permanent occupancy permit for his house so his financing could be wound up and it wasn't picked up then either. It has been since he occupied the building that these issues with the driveway have come up. Had I been aware this would happen, I would not have issued even a partial occupancy permit. I would like to solicit your support for making Mr. Vichi do what he has to do. It is not just an issue of his driveway, its interrupting the drainage on Taylor Hill, it affects other people.

Further discussion

Fairbrother makes the motion to require Mr. Vichi to abide and meet terms of driveway permit in granted 2004; putting in a 12" culvert and paving the first 15 feet from the road edge. Mr. Bergeron to draft a letter to Mr. Vichi stating he is not in compliance with his permit and to be in compliance he needs to install 12" culvert and pave the end of his driveway by November 15, 2012. Mr. Jensen and Board of Selectmen to be cc'd on this. Seconded by Allen, approved unanimously. Allen – Aye, Boutwell – Aye, Fairbrother - Aye

If November 15 comes and nothing has been done, Housing Court can enforce this, Mr. Vichi has an open permit on a garage that does not have a certificate of occupancy.

Other

Bergeron: We found the leak in the Montague Center water line; it went under pressure testing today and passed with flying colors. Thanks his guys for sticking with it, Mike Brown and his crew for helping them out and John Rastalis. From what I understand John and Mike will be sterilizing the pipe this Wednesday and John will speak to his commissioners about accepting it and we will put a temporary black top patch over it for the winter so we can do it right next year.

-Cable Advisory Committee had their Ascertainment Hearing a while ago and was kept open until October 14, 2012 in order to get all the data together. This was sent off to Peter Epstein, it was a great hearing.

-Received survey regarding Montague Center Post Office. There will be a meeting held on November 16th to answer questions people may have. Four options to check off.
