Pole Location Public Hearing, Gary Davol, G4S

4 new poles will be placed on the north and south side of Millers Falls Rd. from Lake Pleasant Access Rd to Aviation Way to facilitate the MassBroadband 123 Project, bringing internet to Western Massachusetts Davol: We are looking for permission to place 4 new poles 1 on the north side, 3 on the south side of Millers Falls Road. We are trying to link the pole lines together there to facilitate the MBI broadband fiber optic cable to come through in town. They would be 40 class 5 poles, 40'.

Mickey Longo: The Airport Commission was notified and personally has no issues. I'm not sure if CFR77 requires anything within a certain distance of the airport runway on a 3200' runway has to have form 7460-1 be filed with the FAA and I don't know if that was done and if it wasn't done, I brought all the stuff for you.

Davol: Not sure if it was sent in or not, but will look into it.

Peter Vichi, 11 Taylor Hill Road, votes may be taken **General Concerns**

Vichi shows Board pictures of area he is talking about

There were pictures shown of a storm drain that he had concerns about previously, but it has since been cleaned out

Vichi: Bought house in 2004 and had no issues driving onto the land. At that time the Building Department said we needed to put a culvert in as part of our permit. I didn't argue it at the time, but don't see how it will work. I was looking to see if we could reach another kind of solution that wouldn't involve a culvert but maybe crushed stone or something. The water doesn't go to that part of the land, the culvert seems like an overkill. I wanted to ask if the town would address the tar crumbling on the mailbox side.

Bergeron: We can take care of that sometime next week.

Vichi: Contacted excavator Larry LeClaire, and if you insist on a culvert I'll work towards getting a culvert in. I was hoping I would still be able to maintain off street parking.

Bergeron: The culvert will be under your driveway. The whole reason I required a culvert at that time, 2004 is because that ditch has been there, and that does collect quite a bit of water coming down between the now existing inlet to his driveway. I can talk with Larry LeClaire of L &F and see if he agrees or disagrees with the culvert or even the size, but something needs to be put in there to prevent the washout. The apron needs to be paved to prevent the breaking up of our roads. The ditch is not being filled in, it has been there all this time. Filling it in causes other issues. Historically there has been a ditch there. Maybe a 12" culvert will work. I will set something up with Larry LeClaire tomorrow.

Fairbrother: You have a building permit which requires a culvert and paving. After the last meeting we gave you a deadline of November 15th. It seems we can probably arrive at an amicable solution to make everyone reasonably happy. I would suggest you have an onsite with Mr. LeClaire or his representatives and see if something can't be worked out that complies with regulations and addresses some of their concerns, then comeback. Lets put a hold on the deadline, but not permanently. Tom will report back to Frank

Frank Abbondanzio, Town Administrator Update on 1 Day Liquor Licenses

Abbondanzio: Last week you asked to check with Town Counsel to see whether there was any exception that would be made under the conflict of interest law and your ability to vote on the one day licenses because they typically don't buy liquor from you for the one day licenses because it is usually beer that is served at those events. I talked with Greg Corbo about it and apparently there is a statement that you can read as long as you are told ahead of time that the establishment won't be buying liquor from you, it will be serving beer and not all alcohol. If you read the statement in the e-mail that I provided a copy of each time and file the statement with the Town Clerk you are able to vote and not be in a conflict of interest under Chapter 268A. The statement is pretty straight forward, because you typically would recuse yourself from all alcohol where your vendor does provide liquor to that establishment, you wouldn't be able to vote and you understand that, but this is an unusual circumstance where you would not be providing it and therefore would not be in conflict of interest. Each time someone comes in with a one day, prior to that one day license being voted upon, we need to find out from that person if they are going to be buying all alcohol and your employer will not be providing alcohol to that one day license. In that case you read the statement and file it with the Town Clerk.

The Rendezvous, Suzees Third Street Laundry, Fashion Show

The police chief has signed off on the event and we have received certificate of insurance. Seconded by Boutwell, approved unanimously. Boutwell – Aye, Fairbrother - Aye

BadgeQuest Police Chief Assessment Center Results and next steps
