Request for Representative to serve on Search Advisory Committee for Superintendent at GMRSD

The Gill-Montague Regional School Committee is currently searching for the next Superintendent of Schools. To help us with this most important decision, we are seeking representatives to serve on a Search Advisory Committee, which will be responsible for narrowing a semi-finalist field of eight to ten candidates to three to five finalists. This difficult task will require that the representative commit to the interview schedule. Only those representatives who participate in all the interviews will be allowed to take part in the finalist selection. The Search Advisory Committee will be comprised of fifteen (15) individuals (3 teachers, 3 parents, 2 administrators, 1 student, 1 senior citizen, 2 Select Board members (one from each town), 1 Sped Director and 2 community members) representing various groups within both communities. This committee will meet with our search advisor, Pat Correira from the Massachusetts Association of School Committees on Thursday, January 17, 2013 at 6:00 p.m. and Wednesday, February 6, 2013 to review the selection criteria and compose questions for the interviews. The interviews will take place on March 11, 12, 13, and 18 and 19, 2013. Interviews will be scheduled beginning at 6:00 p.m. each evening and ending at 9:15 p.m. Each interview will last one hour and there will be a fifteen-minute break between interviews. Walter Ramsey, Town Planner, Approve and Sign 2013 ABPP Battlefield Grant Application

Ramsey: This is a formal request for the Board to authorize the submission of this grant application to the American Battlefields Protection Program. This is a federal grant from the National Parks service for \$40,000 and the town would contract a consultant to actually do this research. Montague would be the lead on this and I would be the project manager. The grant is a partnership with the Town of Montague and the Narragansett Indian Tribal Historical Preservation Office. We are proposing a pre-inventory project that is going to identify the most likely locations of the King Phillips War, Turners Falls Battlefield and associated sites. They are going to examine documentary records and archeological collections, collect oral histories both tribal and Yankee histories, use military terrain analysis to identify the locations of the battlefields and its associated sites. They are going to contact land owners of these areas to secure permission to conduct future archeological testing. The grant is going to enable us to develop the phase plan approach to protect the battlefield as well as associated sites and provide strong information for the locally proposed great falls native cultural park proposed as recently as 2009. Surrounding communities are Gill, Greenfield, Deerfield.

Allen: Earlier when people were talking about Northfield, did they mean to say Deerfield, or was Northfield also interested?

Ramsey: We considered Northfield at one point, but it is not within the scope of what we've whittled down to. Our study area which is quite large about 17 square miles so it is hard to narrow down. The real core area is the area known as Peskeompsut, between Turners Falls and Riverside in Gill.

J. Reynolds: I'm curious about down the road that this will impact local owners of land and so on, so there might be some protection issues here from these lands that belong to somebody else now.

Ramsey: When you talk about protection of land, there are different ways to protect the battlefield and we don't know the best way to do that at this point. This is really about assessing and figuring out the best way to get protection. There are numerous ways the plan could be protected. We need to identify and prioritize it.

Allen: I think there is quite a bit in here speaking to land owners in terms of sensitivity about what might happen and recognizing that you're not really planning on taking peoples land or anything like that, more just talking with people, finding out what they know about it, what they might have for artifacts already and different things like that. I don't want to put words into their mouths.

Ramsey: One reasonable outcome would be to have similar designation to a Federal historic district which downtown Turners Falls is, the National Parks service recognizes as an area of historic value and has similar designation. Just because you own a property in a historic district, doesn't mean you're giving up any interest in it per say.

Joe Graveline: There are two levels of recognitions, one is a broad level the other one is a level that gets more specific. The first one recognizes the area as having historic value but it doesn't limit any individual land or property owner from doing anything with their property. The second level usually brings in the local historic commission, then the local historic commission does an inventory of either areas or homes and then they talk to everyone involved. At that point the people who own the properties are involved in the conversation and will either go along with it or they won't.

Ramsey: Its set up the same way in Turners Falls, you have the option of pursuing historic tax credits if you wanted to do a redevelopment project and there are incentives for you to do historic renovations, but there is nothing requiring you to do it.

Allen: One of the things that is so interesting with this project is to hopefully really delineate where things happened, what was going on and the significance of that.

Harris: I think what we are looking towards is the opportunity to gather accurate information about what happened during that battle. With accurate information to then be able to have a dialog with any community so the community can shape what ought to happen once they understand what actually occurred . In these United States, it's very difficult to tell someone what to do on their property, it is still difficult to do that. If in fact there is a desire to protect a given area that would be done because the land owner has agreed that it is an appropriate thing to do.

Dr. Paul Robinson: It is called a Consensus Building Grant. We'll knock on a lot of doors and we'll see what people think about the idea, we'll look at artifact collections. We try to build support, try to build grass root support. One thing about this park service program its not top down its bottom up. They look for strong local partners. It's really critical for the success of the project. It doesn't go anywhere unless the local people support it. One of the reasons it won't go anywhere if the local people don't support it is because to define the battle field we need to do ecological testing and that will come at a later phase in a later grant if this one is successful. You can't get onto someone's property to do ecological testing without their permission. Without that we won't be able to define the battlefield, we won't even be able to consider putting it on the register. All this is several years down the road. During this time you knock on a lot of doors, you talk to a lot of people, you have meetings, you bring people into the process you talk about the history, you talk about the Yankee history. Turner and Turners descendents will be important in this because as many as 40 of his men were killed on the retreat. It's not just about an attack on an Indian camp, and women, children and old men being killed, it's about 40 English men were killed also. That's why we look at the Yankee oral histories, the tribal oral histories and try to bring it together.

Harris: One of the things we were looking at was how do we help the Turners Falls community, how can we make good on the commitment we made to the Turners Falls community in 2004, to help with your economic development? We don't have money, what we have is access to our side of the history that happened in this area and the possibility is that in defining historically what actually happened here, is we can draw people to this area to learn more about the history. There were a lot of history buffs, there were a lot of kids in class rooms whose parents would be happy to bring them for a 2 or 3 day stay in this area to walk those places once they have been defined. It is our expectation that out of that comes economic development, bed and breakfast, motels the various things people need when they come to a place to spend a few days. If we can make good on what we committed to with this community by working through our combined oral history then we have done what we committed to.

Allen makes the motion to support the 2013 American Battlefield Protection Program Grant package that is being submitted with the Town of Montague as the lead and with our partners and authorize the Chair to sign the document. Seconded by Fairbrother:

Fairbrother: I would encourage fellow board members to vote this down. If someone wants to do this grant for the battlefield, go for it, more power to them; it sounds like an interesting project. What I object to is this Town's participation as a partner in that grant. As I've said before the reason I object to it is the history at the Turners Falls Airport over the last 10 years or so. When that project started up there we had a \$5 million, no cost to the Town, complete rebuild to the Airport. As we sit here in 2012 the project is still far from complete, the taxi way hasn't been touched, some of the navigational aids haven't been installed yet. It was supposed to be a 4200 foot taxiway and runway, its 3200 feet. I was on the commission at the time so I had a front row seat. While there were other guilty parties as well, where we are today has been driven by the actions of certain tribal leaders pressing their points of questionable veracity on the Town and leaving us in a very bad position, we have lost the funding for infrastructure improvements for hangers that we could have already been getting rental fees for. In the mean time we had this project fall apart and with no end in sight, the tribal leaders involved have been paid not quite \$100,000 for their activities at the airport. You talk about bringing financial rewards to the Town, at best you're trying to catch up for lost time, lost money we will never recoup. Not solely but mostly because of the actions of the tribal leaders. I do want to make the point, make it crystal clear to everyone listening, despite what you may have heard, I do not hate Native Americans. I have great respect for Native Americans. There are however 3 or 4 specific tribal leaders who were the ones promulgating all this, they are the ones I'm not too happy with. If it had been someone else other than Native Americans, and gotten us to the same point, I wouldn't be their friends either.

Joe Graveline: I'd like to remind the Board I could probably pack this room with pilots who were not happy about the Airport Expansion project for 4200 feet. Many of them got thrown out of their hangers during that time period were very unhappy with all the activity at the Airport relative to the Airport Commission not the tribes. They signed a document you have in your files.

Harris: I feel what you're saying I feel the disappointment that you have shared with us. Any federal project, a project that utilizes federal funds, federal permitting or is on federal land is referred to as a federal undertaking. Once a project is declared to be a federal undertaking, it accepts certain guidelines; one of those guidelines is to be guided by the National Historic Preservation Act. At the heart of the National Historic Preservation Act is the American question what does the present owe to the past? Indians didn't write the National Historic Preservation Act, but basically it asks what is it that in moving forward and making progress are we about to destroy that cannot be replaced, that is important to American heritage and American understanding of America's soul. That question gets asked on any federal project, any dollar amount. There was an archaeological study that had been built into the grant and our office, the Tribal Historic Preservation Office was a participant in that archaeological study. It was considered that at least going back 12,000 years there might be artifacts on one section of that runway. It so happened that during the examination for that, artifacts going back 2,000, 7,000 and 12,000 years were found. It so happened in examining those artifacts there was an indication something else was going on on the other side of the runway. That is the responsibility of the process, the State Historic Preservation Office, the archeologist were all involved in examining this and satisfying that question, what does the present owe to the past? In that process, what was discovered was a major ceremonial area for which the place that is 2,000, 7,000 or 12,000 years was simply the camping ground. Those artifacts were basically the throw off trash where people spent time when they came to do what they had to do on that other hill. What was attempted then, was to follow the National Historic Preservation Act that goes along with any Federal undertaking to do the necessary due diligence of determining what was about to be destroyed. The hill that was about to be destroyed for cheap fill to go into the runway was actually a place of ancient ceremony. By the time full examination was complete, the time that issue went to the National Register for Historic Places in Washington where the Federal Aviation Administration took the issue to make a determination. When that determination was made, it was made that yes indeed that was a sacred Indian place. When you have a contract, you set forth what you want to accomplish, then you go by the rules of the agreement. I think it is important for us to understand, in acquiring improvements to the Airport, it had to be done by the rules, and it is not the fault of the Narragansett Indian tribe that the ancient ancestors of the Pocumtuck left what they left there, that in fact was found. Because the Narragansetts have an ancient relationship with the Pocumtuck going back to the

events at Turners Falls in 1675 and 1676. This is a place of significance. There are no Federal projects that are planned as a part of any of this.

Brule: I'm a Conservation Commissioner and Airport Commissioner. In the middle of this controversy there are 3 overlaying areas of interest at the Airport; aviation, natural heritage issues and the Native American Cultural sites. Therefore, trying to juggle all of those and to go forward has been a great challenge. From my point of view as a commissioner, the big issue was Chapter 106. When I came on the Commission it was an unknown process. When you bring TF Airport up at meetings with the FAA, they say OMG Turners Falls. It's not because of all the controversy, it's the problem that 106 was not clear, the FAA did not know how to do it, did not enforce its decisions. In my opinion the tribes were trying to sort it out and the Airport Commission greatly entrusted our consultants to guide us. We have had extremely positive meetings with the tenants at the Airport over the last 3 months. A new manager has done wonders so we are moving in the right direction in a whole bunch of areas. My sense was the tribes were not opposed to the extension it's just that the hill was to be fill and it turned out that the hill was not available. The extension is in the capital improvement plan for 3 or 4 years from now; it's still going to go forward and FAA has told us they want to proceed with that extension. Whether or not it happens remains to be seen.

Allen: Having gone through the Airport piece from a bit of a distance, I think there were a lot of issues that came up that people perhaps didn't realize were going to surface or had never been dealt with to that point, and it made things very difficult here. I find myself thinking I want to move on, this is a totally different project, something I feel is very significant to Turners Falls and to Montague. We certainly over the years have had people who have said they would like to change the name of Turners Falls to Great Falls, and we haven't gone that route but there has certainly been a lot of discussion downtown. I think there are some wonderful possibilities that could come out of the results of this phase 1 with Historic Deerfield. I don't think this is that big of a grant, and I would like to see us move a long and get this grant and send it in, get the money so we can proceed and see where we might go in the future. I think it is the future we are actually looking for something that can help all of us; either intellectually, educationally but also help us economically potentially.

Boutwell: I want to echo Pat's sentiments, we all know things that have happened in the past at the Airport, and unfortunately we can't change it, but I'm at a point where I want to move on. I consider the Airport is just a part of this package there is a lot more to be discovered out there.

Allen makes the motion to support the 2013 American Battlefield Protection Program Grant package that is being submitted with the Town of Montague as the lead and with our partners and authorize the Chair to sign the document. Seconded by Fairbrother. Approved. Allen – Aye, Boutwell – Aye, Fairbrother – Nay
