Informational Hearing regarding 7th Street Parking Ban, Chief Charles Dodge

Dodge: Over the years we noticed there is a safety issue on 7th Street when church is in session. We've always looked the other way because of what it is for, for church and we don't want to disrupt people from going to church. I've been through there a couple of times myself and I don't want to pick on any particular age group, but there are some older people that I've witnessed that just open their door and start to go into the street. From what I hear this is very common and not something new. I asked Mike Sevene to get together with Highway Dept. Superintendent to see what they can come up with as a solution to the problem. The solution they seem to have come up with was putting a parking ban on one side of Seventh Street. (Dodge passes out handout) Dodge goes over dimensions of the road. It is dangerous there! They believe the north side of Seventh Street should have the ban. There is already a ban from Park Street on the north side, down to L Street. On the other side of the street there are residences and parking. Going down Seventh St. we figured it would be better to leave parking on that side. There is plenty of parking in that area, it is just going to require a little walking.

Diane Kurkulonis, Sr. Warden at St. Andrews Episcopal Church: Public Safety is also a priority at St. Andrews. We are trying to keep everyone safe and to figure out a solution that would be equitable for everyone. Programs could be compromised without adequate parking (Photos shown). It has taken St. Andrews years to fund renovations to comply with handicap accessibility. Without adequate parking and reasonably accessible parking our Church attendance will drop off and could force us to close.

Dodge: What if we left that section of 7th Street alone and put the ban from L Street down. I'm willing to amend my request to Selectmen and give this a try.
