Board of Assessors, FY2014Tax Classification Hearing, votes may be taken

Miller: Does not have final certification on valuations. The Board of Assessors recommends a 1.315% shift to the CIP classes which is the slightly lower shift than in the previous year. This recommended shift gives the residential class a 60.487% share of the tax levy and the CIP classes a 39.513% share. First light had a \$60 million increase to their value which has resulted in a reduction to the tax rate. I have a great deal of concern about this. The tax rate had to come down because of Prop 2-1/2, we couldn't just take in extra revenue because there wasn't any new growth. The increase is based on a professional appraisal. First light will undoubtedly take us to appellate court and if they win, not only will their value go down, but the Towns tax rate will go up significantly.
