Police Chief Charles "Chip" Dodge, Continuation of Parking Ban on Seventh Street, Turners Falls

Dodge: On June 24, 2013 I came before the board to request putting a parking ban in place on the North side of Seventh Street. At that time it was requested I come back before you before April 1, 2014. I would like the ban kept in place. I was contacted shortly after by Charlie Choleva expressing his unhappiness with the parking ban as he is a resident on that street. It seems to be working great, there is plenty of room on the street. I'm inclined to request that Board continue the ban and leave the signs in place.

Charlie Choleva: We were not available to come to the meeting and thought the request being put out was going to be for only the weekends to cover the church going crowds. There was more discussion about how other things happen at the church during the week and the Selectboard chose to make it 7 days a week. This has really inconvenienced us as our driveway is in the back of the house. We would like to see if we could go back to the original 6:00 AM to 6:00 PM Saturday and Sunday. The houses were all impacted

Discussion about moving parking to other side of the road, but were trying to avoid people crossing the street. Issue of getting a ticket if you park your car on the side of the road for a few minutes and leave a vehicle unattended. Patrons going into the library are not happy parking on the allowed side, due to the slope and not being able to get into that side of their vehicle.

Nelson makes the motion to relocate no parking signs on Seventh Street from the corner of Seventh Street and Avenue A to the alley way adjacent to St. Kazimierz Society (K Street Alley) to the exact same spots but on the opposite side of the road going from Avenue A up to the corner of Seventh and L Street effective as soon as the Highway Dept can relocate the signs, but no later than Monday, April 14, 2014 for a one year trial basis to be reexamined by April 1, 2015. Green house facility is one of three discharges they are allowed to have, due to leaks they had in the system increase alkalinity mitigates effects of copper and with fish health in mind the increased the target alkalinity in the system and the greenhouse which tends to raise the pH. The existing upper limit is currently 8 and they are looking to go to 9.5 and sewer use regulations allows them to go to 11. This will not hurt anything
