Michael Perreault, FRTA, Bus stop improvements at the intersection of Avenue A and Third Street

There have been issues with pick ups. FRTA would like to install a bus stop sign so passengers can be loaded and dropped off. The space would be large enough. FRTA is looking to see if the Town is in favor of allowing them to make improvements. This would be in addition to the one across the street. There would need to be improvements to the sidewalk if approved. FRTA will cover all associated costs.

Fairbrother makes the motion to authorize representatives form the FRTA to install the proper bus stop sign at this location and for the highway dept and planner to further explore installing a shelter at that location. Walter Ramsey, Planner and Conservation Agent Request to renew lease of real property to Judd Wire, Inc. for parking facility on municipal property for 18 months, \$150 rent

Update on re-naming a portion of Greenfield Road from Turners Falls Road to RR tracks

Ramsey reports that FRCOG has no control over the names of county roads. He reported asking residents of the road their preference for a name, and Old Greenfield Rd was the most popular.

Fairbrother makes the motion to put an item on the next special town meeting warrant renaming the portion of Greenfield Road from Turners Falls Road to RR tracks. Seconded by Nelson, approved. Boutwell – Aye, Nelson – Aye, Fairbrother – Nay (doesn't want to admit road will never be reopen)

Montague City Road Bike and Pedestrian Crossing Improvement Project – MassDOT Project #607239 Authorize Professional services change order with Stantec Consulting Services, Inc. totaling \$22,850

Ramsey notes this project will provide safer bus stop and pedestrian crossing on Montague City Road. Cost is 50% more than originally expected. Construction will begin in Summer 2015. There will be a full upgrade of the road including drainage and new bus pullouts. Chapter 90 funds can be used for the town's portion of the project. The town will have to do a right of way acquisition for 14 temporary construction easements associated with the project. Four parties have donated their property for the easements.

Fairbrother makes the motion to authorize the Professional Services Change order with Stantec Consulting Services totaling \$22,850. Seconded by Nelson, approved. Boutwell – Aye, Fairbrother – Aye, Nelson – No (due to a seemingly extraordinary cost)

Dave Brule, Battlefield Grant Study Coordinator, Establish Battlefield Grant Advisory Board to guide the implementation of the battlefield mapping study awarded by the National Park Service Battlefield Protection Program

Brule: On advice of archaeologists, we wanted to appoint an advisory board. The board has been meeting as an ad hoc group. There was discussion about who could be on the group and who could attend the meetings. Jeff Singleton strongly urges the Selectboard to consider adding a Historian to the committee.
