Special Town Meeting

Discussion and vote to approve petition for Governor's Bill to obtain ratification of the actions taken at the October 29, 2014 Special Town Meeting, Gregg Corbo, Kopelman & Paige

Corbo asks if everyone has had a chance to look at draft of letter regarding the Special Act and gives explanation of what happened regarding posting of town meeting. We went forward with the Town meeting acknowledging the error, the Moderator asked for a vote of the meeting to see if the members wanted to go forward and they did, but I

recommend we seek what is called a Governors Bill to obtain a special act to ratify the meeting. This is commonly done in this type of circumstance and what it does is it protects the Town so you have legislative authorization for all the things that were done at the meeting and if there is ever any question you point to the special act and everything will be fine.

Fairbrother makes the motion to authorize Town Counsel to work with the Town Clerk to finalize the letter regarding Governors bill to obtain a Special Act to be signed outside of the meeting and authorize Frank to contact the Towns Legislative delegation, State Senator and State Representative, to obtain their assistance in presenting the matter to the Governor. Seconded by Nelson, approved unanimously. Boutwell – Aye, Nelson – Aye, Fairbrother - Aye

Corbo: There was an open meeting law complaint on November 4, 2014 which claims the Board of Selectmen with full knowledge and intent pursued a Special Town meeting without proper posting this process is designed to correct the deficiencies. In regard to the open meeting law itself, the Attorney General does not have any jurisdiction over any aspect of Town Meeting.

J. Golrick objects to whole line of reasoning

Chip Dodge, Police Chief

Vote to accept agreement with Jody Rattigan regarding her dog named Diamond Marie

- Chief Dodge presented a copy of the proposed agreement (attached) and explained the contents that he and Ms. Rattigan had agreed to include.
- Issues: Chief Dodge indicated that every item except the insurance provision was acceptable and workable. Ms. Rattigan indicated that she was unable to get her insurance company to write the \$100,000 liability policy referenced in the agreement. She felt that her business insurance would cover such claims, but no evidence could be produced substantiating that clause.
- Ms. Rattigan's landlord was also unwilling or unable to provide such coverage.
- Chief Dodge expressed concern that the Town would not prevail in its case before District Court.
- Attorney Greg Corbo advised the Board to run the agreement by Town Counsel before agreeing to it, and to get
 the necessary hold harmless and indemnification and other appropriate language added to it before bringing the
 agreement back to the Selectmen for signature.

Nelson makes the motion to authorize the Chief to continue to work with Jody Rattigan to develop a term of agreement on the seven points and come back before the board next week. Seconded by Fairbrother approved unanimously. Boutwell Aye, Fairbrother – Aye, Nelson – Aye

Rodney Madison, Madison on the Avenue, 104 Avenue A, Turners Falls Presentation from Police Chief regarding Licensing, Building and Health Inspections, Produce proper business Documentation establishing the business

- The Board of Selectmen took action on 4 items relating to Rodney Madison's business located at 104 Avenue A, Turners Falls. These include: a permit to place objects in front of his store on the sidewalk; a permit to place objects in the planter; a permit to place a sandwich board advertising his business at the corner of Avenue A and Third Street.
- Several issues were raised in relation to the permits being requested. Did Mr. Madison have a license to operate his business? Mr. Madison produced evidence that he had both a Town and State business license. Did Mr. Madison have adequate insurance coverage? Mr. Madison produced an insurance certificate. Was the business location adequately served with electricity? Mr. Dodge indicated that he has satisfied that the business now had electricity. Mr. Madison confirmed that the Town electrical inspector had required certain things to be done and that the requirements had been met.
- Mr. Madison expressed concern about comments made the prior week about his business not being licensed. He felt that these comments may have discouraged people from patronizing his store. He asked the Board to affirm that his business was in fact a licensed business.

Use of Public Property at 104 Avenue A: Place items in front of store on the sidewalk 4' 8" x 22' extended from the building

Nelson makes the motion to allow use of public property at 104 Avenue A to place items in front of the store on the sidewalk protruding 4' 8" going 22 feet length of building, insurance is included, with the understanding should any item be damaged by DPW the Town will be held harmless. Seconded by Fairbrother. Approved. Nelson – Aye, Boutwell – Aye, Fairbrother – Nay (not voting for something that has already happened)

Use of Public Property at 104 Avenue A: Sandwich Board Sign 3-1/2' x 2-1/2'

Nelson makes the motion to use public property at 104 Avenue A to place a sandwich board sign 3-1/2 'x 2-1/2' on the public side walk year round, being relocated during inclement weather, sign to come inside when business is closed, with the understanding should any item be damaged by DPW the Town will be held harmless. Seconded by Fairbrother, approved unanimously. Boutwell – Aye Seconded by Fairbrother approved. Boutwell – Aye, Nelson – Aye, Fairbrother – Aye

Use of Planter in front of 104 Avenue A

There was some discussion about the role of the Streetscape Committee in the approval of permits to place objects in the planters. It was acknowledged that that planter guidelines brought before the Selectmen in October 2013 were never formally approved an there was no follow up to make the minor last changes that are needed. Mr. Abbondanzio urged the Board to accept the guidelines, as is, at their next meeting, as they include regulations that protect town interests. The Selectmen chose to make their decision about the planter, without a reference to the guidelines.

Nelson makes the motion to allow use of the planter in front of 104 Avenue A to Rodney Madison for decorating, insurance is attached. Should any item be damaged by DPW the Town will be held harmless. Seconded by Fairbrother, approved. Boutwell – Aye, Nelson – Aye, Fairbrother – Nay because items already in the planter.

Mr. Nelson would like to see the Planter guidelines brought back before the board after the first of the year

Nelson and Boutwell both state they feel Madison on the Avenue is a legitimate business. Fairbrother feels it is their opinion and he cannot comment as he does not know what the qualifications are for a legal business



HOW IT WORKS:

The Massachusetts Fuel Assistance Program helps needy families by paying a portion of their heating bills from November 1 to April 30.

If you are a Massachusetts resident living on a low or fixed income, we encourage you to apply.

WHO SHOULD APPLY?

- Renters and homeowners who pay for their own heat
- Renters whose heat is included in their rent. (Those who have a housing subsidy must not receive a utility allowance)

WHO IS ELIGIBLE:

Eligibility is based on the number of people in your household and the combined gross (before taxes) income of all persons residing in the household

Use the chart on the other side of this pamphlet to see if you may qualify.

WHERE AND HOW DO I APPLY?

We cover Franklin and Hampshire Co. We have interview sites in Greenfield, Northampton, Ware and Orange

All appointments must be made through our main office by calling:

If you are a first time program applicant, you must apply in person. If you applied the previous year, you will receive your application by mail and will not need to apply in person.

If you are homebound, call us for help in filing an application.

WHAT WILL I NEED TO PROVIDE WHEN APPLYING:

For the person who is applying, bring:

- Social Security Number
- Proof of identity (picture ID)
- Proof of address
- Homeowners: mortgage statement, real estate tax bill, homeowners insurance bill
- Renters: copy of the lease Subsidy verification
- Heating bill
- Electric bill
- All income for the four weeks before the appointment

For all other household members, bring:

- Social Security Number
- Dates of birth
- All income for the four weeks before the appointment

Income includes: wages, self employment, TAFDC, EAEDC, Social Security, SSI, child support, alimony, dividends and interest on bank accounts, rental income, unemployment benefits, pensions, cash prizes and regular support from family and friends; plus any other income you receive.

Additional information may be needed to complete your application.

TO RECEIVE FUEL PAYMENTS:

When you become eligible for fuel assistance, we will notify your vendor of your award amount. Your vendor will bill us directly for usage during November 1st to April 30th. You do not need to send ANY bills in. If you either move or leave your home during the winter months you must notify us immediately.

OTHER BENEFITS:

When you become eligible for Fuel Assistance, you may possibly also become eligible for additional help:

- Discounts on some electric and gas utility rates
- A discount on your telephone bill, depending on your type of service
- Weatherization
- Heating system repairs or emergency replacement, if you are a homeowner.
