The money will not be available until July 1, 2015.

Walter Ramsey, Town Planner and Conservation Agent Sign Montague DCR Recreational Trail Grant Application – Dry Hill Cemetery Access Trail

Ramsey: One of Towns goals is to improve public access to Dry hill Cemetery Access Trail. I am proposing multi use access path about 2 miles long that would benefit a wide variety of trail users. There is the opportunity to apply for the Conservation/Recreational Trail Grant Program. The grant would fund specifically way finding signs as well as Trail markings so the public can find the cemetery and know where it is. One of these signs would an interpretive sign at the cemetery itself. One of the problems if you know it exists, it is really hard to find and you could walk right past it and not even know it is there. There is a lot of good history to be told there, it is one of the oldest cemetery's in town, it hosts at least one Revolutionary War soldier. It does not look like it is a public resource. You could walk to it from Dry Hill Road but there are no trespassing signs closely marked on every tree along the corridor so it does not look like a public place; this would do a little bit to open this up to the public. The match from the Town would be doing some work to the access road dry hill cross road which is a way of getting to the trail via East Chestnut Hill Road. One of the work items is to repair a culvert that was washed out and has created a barrier to getting a maintenance vehicles over there. Elderly could get there under this proposal via a 4 wheel drive vehicle. One of the selling points for this grant is the site offers one of most beautiful vistas around, connects directly with the New England Scenic Trail, it is about 1/4 mile from Wendell State Forest and abuts the Montague State Forest. The request under this grant would be for \$6,400 to produce these trail kiosks. This does not reclaim property next to Senn property. This would be a good step in the right direction.

At this meeting we will present information on the Federal Energy Regulatory Commission (FERC) process as well as potential impacts during pipeline construction and operation that towns should be thinking about. We will also invite Scott Jackson from UMASS to present his GIS natural resource mapping and assessment of the pipeline route. We would like each community to appoint 1-2 representatives from among members of the Select Board, Planning Board or Conservation Commission and/or Town Administrators.
