Meeting was opened at 7:00 PM in the Upstairs Meeting Room. Present were Selectpersons, Chris Boutwell, Mike Nelson; Rich Kuklewicz, Town Administrator, Frank Abbondanzio (absent), Executive Assistant, Wendy Bogusz

Approve minutes of May 19, 2015, if available

Kuklewicz makes the motion to approve the minutes of May 19, 2015. Seconded by Boutwell, approved unanimously. Boutwell – Aye, Kuklewicz – Aye, Nelson – Aye

Public Comment Period: Individuals will be limited to two (2) minutes each and the Board of Selectmen will strictly adhere to time allotted for public comment:

Reynolds: Last week I mentioned having some of the Selectmen meetings at different villages, if we can't move the meetings to different villages, have you thought of ways to get more people involved or how they can speak at these meetings.

Nelson: I've spoken with MCTV, we cannot be live and I have gotten the impression the public likes our meetings to be live.

Kuklewicz feels we could go to villages to show support in other ways outside of the normal meeting schedule

Montague Senior Center Planning Study Results Presentation

Ramsey: This has been an ongoing study, the Town received a grant from the Park Services. Everything going well, one meeting has been held, two more still need to be held. The tribes are participating, we want to be wrapped up before August 2016. We are hiring the tribes to give their historical account of what happens, total cost for each MOA is \$8,500. The tribes agree to attend meetings, put their account into writing for the final report. Counsel has not reviewed this at this time.

Kuklewicz: Feels getting out of the agreement may be difficult, as it says mutually agreed. Wants Counsel to review first.

Reynolds asks what the town will gain from this and Ramsey replied the Town will become owner of all material; reports will get distributed to libraries and the Town hall will have a copy. The study is to figure out what happened here and what is worth protecting.

J. McNamera: Anything in the original state is probably wiped out. Ramsey said what makes this special is the Native Americans have taken the time to tell their story, thinks what we are doing is unique and exciting to try and set the story straight according to the Native Americans.

Ramsey will have Town Counsel review documents and be back to the next meeting.

Recommendation for award of Avenue A Streetscape Enhancement Project to Mountain View Landscape and Lawncare, Inc. \$396,550

Kuklewicz: New lights are no way the quality of the old lights, wants to know the plan on the lights being taken out and if they should be refurbished for future use.

Nelson: Previously suggested in Phase 2 that the good poles be saved for Peskeompskut Park. Hunter: This is part of Phase 2, salvaging all lights and they will be stored by the Highway Department; a pallet of bricks is also being saved (in the contract)

Ramsey: Not feasible to keep the fixtures, double the cost; lights now are incredibly difficult to repair. Two poles are being saved the one in front of Spinner Park and Town Hall.

Kuklewicz makes the motion to award the contract for Avenue A Streetscape Enhancement project to Mountain View Landscape and Lawncare, Inc. in the amount of \$396,550. Seconded by Boutwell, approved unanimously. Boutwell – Aye, Kuklewicz, Aye

Bourbeau: Absentee ballots were made available to the public on May 5, try for 3 weeks in advance but there was a glitch this time with printing of ballots. All but 4 ballots were returned to her. The post office said Greenfield delivery service is two days. I do not know why it took so long to reach Ms. Tegal. I did my job, there is no MGL that states when they have to be mailed out. These ballots cannot be sent out 45 days early. Just not possible as I am still waiting to hear from people who want to submit their names for nomination. There is a law, but it is a Federal law that pertains to those elections.

J. Burbank: Sam attended a CAC meeting and was awfully emotional, feels motivation is more opposing a committee member than interest of the CAC. We are making good headway with two contracts we are working on and doesn't see Sam helping them at this point.

Kuklewicz saw a disagreement but good work was getting done. Feels the committee makeup is good at this point and is not in favor of changing anyone at this point.

Gilford: There is no criteria except being a resident, there isn't a balance. There is no limit to the number of people that can be on the committee, it is the Selectmen's decision not the CAC's.

Boutwell makes the motion to appoint Sammy Gilford to the Cable Advisory Committee until 6/30/15. Seconded by Nelson. Boutwell – Aye, Kuklewicz – Nay, Nelson – Nay
