Ramsey: Counsel gave his approval for the contracts. Payments are coming from the Federal government. One tribe wanted lump sum payment, two wanted hourly payments, total cost is \$8500 of all three contracts. Counsel confirmed this has nothing to do with Airport project.

Vote to submit formal complaint to Attorney General regarding DPU denial of Montague's request to have Plan-NE intervene on its behalf in Berkshire Gas Hearing before DPU

Diane Mcavoy and Ariel Elan

Mcavoy outraged by denial of request that we were refused intervening status with the DPW. We were at a deadlock at what to do next.

Elan: Has proposed resolutions that she would like passed. This has to do with moving forward from the fact that the DPU has refused to plan for the NE the intervener status in the Berkshire Gas proposed contract agreement of KinderMorgan. Plan-NE, which we joined in order to have a status and voice in those hearings are appealing this decision to the DPU Commissioners. There was a very well informed testimony to the DPU at a hearing held on June 11th. These resolutions are ways the Selectboard could move forward from this denial of access and present at the DPU. Reads proposed regulations into the record:

"Resolved that the Montague Selectboard will request a meeting of its representatives with the Attorney General to discuss our concerns regarding Berkshire Gas and the Kinder Morgan pipeline, including the Berkshire Gas moratorium on new and expanded gas service in Montague."

"Resolved that the Montague Selectboard will write to the Department of Public Utilities protesting the exclusion of Pipeline Awareness Network of the Northeast (PLAN-NE) as an intervenor in DPU docket 15-48, as Montague is a member of PLAN so that PLAN can represent the Town's interests in this and related DPU dockets."

McAvoy feels that with Montague being part of the moratorium and pipeline go right across the plains and under the river. We need to get more proactive like Deerfield, we need to do more. Perhaps we should be filing injunctions with DPU, with the Attorney General, with the Governor

Tara?: What Ariel is doing is wonderful. Its filing for intervener status to get official documents on time, otherwise you don't know. Beyond intervener status there are other things people are doing. Deerfield is filing a complaint with the Federal government stating the entire process is fraudulent, that the pipeline is not needed for example and their board of health is passing ordinances that a pipeline technically couldn't meet. Massachusetts is a home rule state.

Discussion

Elan would like a pipeline group that includes a Selectmen being a part of it.

Abbondanzio states we would have to go to Town Meeting if there are any expenditure of funds required. Reynolds feels that after July 1 we would not need to go to Town Meeting for the Money. Abbondanzio feels we would need a commitment if it was a significant expenditure.

Kuklewicz would like to research a little more around the injunctions to see if he will endorse one way or another. I don't think I'm prepared at this moment to sit in front of the Attorney General. I have my personal opinions, but I think we need to have the technical information, and I'm not sure who we would have in our corner regarding this at this time. I agree with it in principal, I just don't think we have any staff with the technical information.

Ramsey has been going to Regional meetings with the FRCOG with Selectboards from the Franklin County towns and they are pursuing their own strategies which overlap this DPU intervention. At the FRCOG level they are preparing for the FERC process. The county is talking about coming back to the Towns asking for them to chip into this.

Discussion

Kuklewicz makes the motion to ask staff at Franks direction to review the two proposed resolutions that would be sending a letter to the attorney general to discuss our concerns around Berkshire Gas/Kinder Morgan pipeline, the moratorium and the expanding gas service in Montague and being denied gas service. Second letter being addressed to the Dept of Public Utilities protesting the extrution of the pipeline awareness network as an interveenor in the DPU docket #15-48 and explaining the towns interests and why we feel it was inappropriate. Seconded by Nelson, approved unanimously. Kuklewicz – Aye, Nelson - Aye
