T. Campbell: Gives overview of what an audit does and does not do. We can't guarantee every dollar spent or all funds received were done in accordance with State and Federal Laws and Regulations or even internal town policies. Our audits are designed under a concept know as materiality. Materiality will vary on the size of the entity. During the Fiscal year 2015 audit the materiality for the Towns general fund, or the town's main operating fund was about \$130,000; it does not mean we do not look at amounts below that figure we certainly do, it just means the auditing standards say we should design our tests to focus on transactions and balances that are at or above that level. During the audit we spend a good deal of our time with the higher risk departments such as the Treasurers Office, Collectors Office, Assessors Office and the Accounting Dept.
