Jeff Singleton, Foundation Budget (Chapter 70) Review Process

Singleton goes over letter from the GM Regional School Committee regarding the issue of the adequacy of the state's foundation budget. The Foundation Budget Review Commission looked at whether the states foundation budget has kept up with inflation in certain areas and they did find out that certain pieces of that budget have not kept up with inflation over time. The pieces identified were employee health insurance and special education as well as low income students and English Language Learners. They made a specific proposal to phase in a more adequate foundation budget over 5 years and the total cost of that is around \$700 million dollars. They had a number for a one year phase in which the state definitely is not in favor of and then they had the number for one year of a five year phase in which would add \$154,595,270. My concern is they need to listen fairly quickly on who gets what for implementation. When you run these numbers through the foundation budget and they come out the other side the numbers are all over the place and don't have a lot of rationality to it. When you run numbers through budget, the Asking Selectmen to ask DESE to cost this out

Thought it was a great opportunity to reform the Millers Falls Community Group then we could start with repair on stairs, clean up of area and other areas in Millers.

Ariel Elan, Pipeline updates

Elan: Asked by two people to give update at the public meeting. For specific details go to massplan.org including testimonies and court hearings. On 4/15 in Pittsfield District Court, Kinder Morgan is asking to enter and cut in the state forest, case seen as test case over article 97 or whether Art. 97 has it's own power to protect land from this kind of project. At Dept. of public utilities, 3 proceedings going on, and deadlines given. In Montague's Intervention and Berkshire Gas attempted contract to use supply path of NE Enegy Pipeline our expert witness information was filed. Ariel gives updates on moratorium, contributions from other towns, Northfield will be contributing \$5,000, Gill has contributed \$5,000 several towns are voting to support the efforts at their town meetings Ashfield, Conway, Leverett is asking for \$5000 Deerfield is asking for \$10,000, Warwick \$3,000 and Wendell \$2,500. There is a fundraiser on 4/23. People that understand the value of this intervention are donating. Millers River Watershed Council has offered to be our fiscal sponsor and will put a place up on their website for people to make donations. This will be discussed at our next meeting. Northfields donation will pay for the March legal bill.
