## WPCF reorganization proposal, Board of Selectmen's response

Kuklewicz: As I said at the last meeting, the Board wants the staff at the WPCF to be treated in a fair manner, unfortunately there are some issues around bargaining that we can't just make changes to peoples positions on the schedule. At our discussions we felt it was best to continue with a superintendent. We understand the work being done at the plant and we are looking for a Superintendent that understands the unique structure and unique process and is willing to come in and embrace that process and learn because we know it's not a standard operating procedure. Frank and I discussed crafting an advertisement looking for superintendent that includes the unique collaboration going on between the Superintendent and the staff and try to find someone that fits that profile so we can continue to grow and mature the process that has been initiated. The Board is willing to talk to UE about a technical schedule recognizing the licensing and extra training and work that staff members at the plant do that require higher licensing in that particular grade. Job descriptions are part of collective bargaining and will talk with union about this. The board is listening but are not able to do things as they were presented.

Abbondanzio goes over what he plans to add in the job description,

Peura: Asks who is going to teach this person how to do the job, as it is not in the current job descriptions for the current employees. So other members of the union are going to hold us back?

Kuklewicz explains when you change the job description for one person it has a ripple effect. We are here to protect the town.

Abbondanzio: Going into negotiations it is important the Selectboard supports the position that will benefit the workers at the treatment plant.

Kuklewicz: Need to do this through the bargaining unit. We have told you we will negotiate the best we can to be fair. Proposal to have a shared management was not in the best interest of the town. We voted to have a superintendent managing the plant. Wants a single person responsible for what is happening at the plant.

Trombley: Some of the issues is information transfer between Frank, the Board and the plant. I've asked people to come to the plant. This is a very large change from who supervised last year, just don't get the part where you don't come talk to the staff as a whole, I'm not saying you're going to sit there and negotiate with the staff, I'm just saying you should be listening to what they have to say. I'm feeling slighted and thinks the staff has also.

Kuklewicz: Has said more than he should, more then the attorney has advised. Felt should have discussion in proper venues. Cannot just make changes, have said over and over how much we appreciate what is being done. We are not a private business, we have constraints, don't know what else we can do.

Tyler: How can they get a meeting with Sewer Commission not the Selectmen. Where can they make the separation and be heard by the sewer commission and you take off the Selectmen hat.

Kuklewicz: They wear two hats and are one of the same
