FY2015 CDBG Informational Meeting Master Plan for Rutter's Parks Project

Jon Dobosz: Here to give update on Rutter Park Master Plan process. Master plan was with CDBG money FY2015 application; the projects master plan committee was established last winter/early spring, has 5 members and they were put in charge of picking a firm to conduct site analysis. Three firms applied to the RFP and the committee picked GZA Environmental in Springfield. Since Spring, we've had 5 public hearings and the attendance has been very strong. Design concepts and park elements were decided through input from those in attendance at the public hearing based on needs assessment.

Anya Duffey: GZA Environmental: Goes over Map showing the Master Plan as it stands now, which is a process of 4 meetings and features all elements that were important to the community. This level of design would allow you to submit the plans to funding agencies.

Walter Ramsey, Town Planner

Green Communities FY16 Annual Report

Ramsey: Part of being part of a Green Community is issuing an Annual Report and we did not do one last year so this is for two years. There are 5 Criteria's that need to be met: Criterea 1: Provide as- of right siting for renewable/alternative energy generation, research & development, or manufacturing facilities. Montague has as-of right siting for large scale solar and renewable energy reseach and development in the industrial district. Renewable energry reseach and development is allowed by right in the Historic-Industrial District. Criterea 2: Adopt an expedited application and permit process for as-of-right energy facilities. Montague has two Chapter 34D expedited permitting sites that would allow energy facilities by right: Strathmore Mill and Sandy Lane Landfill. No projects have been permitted to date, however there is a pending permit application for a 6.4 MW facility at Sandy Lane, expected to be constructed in the next FY. Criteria 3: Establish an energy use baseline and develop a plan to reduce energy use by twenty percent within 5 years. Overall Montague's energy use has been reduced by 19% since baseline year FY08. Our buildings have a 17% reduction. Electric use has increased 67% (1,835 MMMtu) at the Water Pollution Control Facility to accommodate a new treatment process to treat out of town sludge for revenue. If we account for that process, the Town has reduced energy use by 26%! Since 2010 the Town has completed 12 Energy Conservation Measures at the Town Hall, Public Safety Complex, Water Pollution Control Facility, Carnegie Library- with projects underway at the Shea Theater and Sheffield School. The 12 complete measures save the town \$36,241 annually. Criterea 4: Purchase only fuel-efficient vehicles Since the Town adopted a fuelefficient vehicle purchasing policy in 2010, the town has replaced 4 (non-exempt) vehicles with fuel efficient vehicles. Note: The majority of Montague's fleet is exempt. Criterea 5: Set requirements to minimize life-cycle costs for new construction Montague adopted the Stretch Code in 1/1/2011. Since then 11 new single family homes,

2 industrial buildings, and one residential retrofit have been built to stretch code. 10 of these projects occurred in FY 16
