Tree Committee Update

- The Tree Advisory Committee has nine members at this time.
- Ellis went on a walking tour of Millers Falls with the committee, specifically focused on the treescape.
- The committee's present agenda includes developing a charter and a set of priorities, including looking at model practices for tree bylaws in communities and to figure out how best to provide technical assistance and support.
- The committee is considering the notion of creating a wood bank, a volunteer-run organization that would create some wood fuel supply that could be available upon request to members of the community.

Board and Committee Email Strategy

Ellis: One of the concerns as public records law becomes more robust is making certain that we're properly protecting all of our Town volunteers who may work on boards and committees, specifically as they may communicate with email. We're working on doing a lot of education to make sure that boards know what the boundaries are and what constitutes violation of an open meeting law in the context of email. Also, for people who may be using their personal or business account, those records potentially could be subpoenaed if there was an issue with a suspected open meeting law violation and there was concern on the Attorney General's part that there wasn't appropriate compliance with provision of records. In meeting with our IT staff and the Town Clerk, we talked about (a) making sure we have full contact with all board members, and (b) communicating very clearly with them that we

strongly discourage the use of business and/or non-dedicated-purpose personal accounts. We would give them instructions for how to set up an account at no cost to themselves that they can use for their Town business, make sure they have a full knowledge of what the law is and what their vulnerabilities are, and create a full database of what people's preferred emails are. This is a more feasible, cost-efficient plan, and one that supports creating a better Town-wide communication strategy.

Municipal Vulnerability Preparedness Grant Proposal

Ellis: According to the Office of Environmental Affairs, the State has made available technical assistance to support community readiness and resilience to climate-change-related disasters and issues. The technical assistance is intended to be a support for the pursuit of a designation as an MVP (Municipal Vulnerability Preparedness) community, and in the future we anticipate that there may be monies available from the State focused on emergency preparedness that, if it's a grant competition, may only be open to MVP communities or MVP communities may have additional bonus points in the competition. This technical assistance will come in the form of facilitated workshops using a very specific planning process for weighing risks and bringing data into the process. We anticipate is that we will work with the FRCOG as the partner that assists in facilitation and so we collaborated with them in the development of our proposal for this. This will likely have an expedited process as we have a significant head start, having just completed the hazard mitigation and wildfire prevention plans, which were formalized in 2015. We submitted that proposal last Friday and we hope to hear back from that in early July.

Other/Repaying of Route 63

Ellis: The State DOT and will be using some end-of-year monies to do a repaving of Route 63 from Sunderland up to Northfield. They're looking to have this done before the end of June.

MSPCI Program Income Hearing: Spinner Park Master Plan; \$7,500

Ramsey: We have money that's remaining from the contract from the Streetscape Improvement Program that's left over from the Community Development Block Grant Program, and we need to think of a way to reprogram and use these funds. We looked at some of the options, including doing a complete design for streetscape improvements for all of Avenue A as well as expanding the street lights a little bit more. Then Skinner Park was brought to my attention. At a community concert the other day, we realized that the planters are beyond repair, the curb cut is falling apart, and the fencing is falling apart. I'm here to request to allocate \$7,500 from program income funds to do a schematic design of rehabilitation of the park, which will involve creating a new design of the seat walls of the bed, fixing the lighting in the park, fixing the crumbling seat walls and the curb cuts, redoing some of the plantings, and recommending a new fence.

Nelson makes the motion to authorize the Town Administrator and the Town Planner in consultation with the appropriate parties to move forward in identifying a vendor to do a master plan for Skinner Park for up to \$7,500. The source of funds for that will be the Massachusetts Small Cities Program Income line of our budget. Boutwell seconded, unanimously approved. Nelson - Aye, Boutwell - Aye, Kuklewicz - Aye.
