Approve and Endorse 2017 Open Space and Recreation Plan

Ramsey: The Open Space and Recreation Plan is something that the Town needs to update every seven years. The Conservation Commission is taking the lead on this update. We received some State funding to write up the plan, as well as some technical assistance from the FRCOG Program. The Open Space and Recreation Plan inventories cultural and natural resources in Town, identifies gaps and needs, comes up with a plan to address those over a seven-year period, and helps obtain grant funding to implement some of the projects. There was a public survey to which 200 people gave their feedback, as well as a public forum which was attended by about ten people. In addition, during February vacation, we held a Favorite Places in Montague Exhibit in which children were asked to draw pictures and describe their favorite places. Since the 2010 plan, we've completed Unity Park, built the Skate Park, fixed up a pedestrian bridge in Montague Center North Street Wildlife Management area, posted some trail systems in the Dry Hill Hannigan Brook Watershed area, and put 500 acres of farmland into permanent protection. About 39% of the Town is permanently protected and undevelopable and up to 60% has some level of protection. The plan looks at strategies for protecting farmland in the future. Regarding recreation, public feedback included wanting to maintain existing facilities, increase recreational programming, add an outdoor swimming facility, and add more bike and hiking trail systems around town. The list of action items is posted on-line under the Planning page, public comments will be taken until the end of the month, and there is a station set up in the Town Hall downstairs where people can help prioritize which of the action items to tackle first.

Ellis: There is a Housing Economic Development Grant for assessing our infrastructure, which is a community compact agreement that the Town had prioritized two specific areas for support for the community compact, which seeks to move towards best practice. One of those is in relation to the Open Space Planning. We will be hiring an engineer to examine gateways to the canal district. Conversations are ongoing about improvement of access and/or bridges from the IP/Headgate Bridge, the pedestrian bridge to the Strathmore, and also the Sixth Street bridge that goes over between Railroad Salvage and Franklin Regional Housing Authority. We think we're going to focus the energy on that latter bridge because we have an Economic Development Project in the form of the Railroad Salvage Restoration that's ongoing, and we also have interest in improving both accessibility to the Patch, but also potentially long-range access to the paper mill site as well.
