Evan Gregg, Makeshift, LLC

Use of Public Property: Various locations in Town between 7/31/17 - 9/1/17 for filming of scenes for the film "The Man who Killed Hitler and then The Bigfoot"

Nelson makes a motion to approve the Use permit filed by Makeshift LLC for filming of the movie production "The Man Who Killed Hitler and then The Bigfoot" at various locations throughout Montague as identified in the attachments to the permit application. Said filming is to occur between the dates of July 31st and September 1st, 2017. Due to the unpredictability of movie production, a definitive schedule for filming at the above locations is impractical and the Board acknowledges that some additional film sites may be considered and approved through this application. For this reason, the Board requires that updated written reports of film scheduling be submitted via email to the Board, Police Dispatch, and the DPW Superintendent's Office at least three days in advance of filming. The Board Chair is granted authority through this option to approve these updated schedules in consultation with the Chief of Police on an ongoing basis. Further, the Board votes to approve liability insurance requirements of \$1M individual and \$2M aggregate for this permit, with the Town named as an additional insured. Kuklewicz seconded, approved.
