Public information session: To receive public comment and to discuss the draft proposal and draft analysis of Brownfield Cleanup Alternatives

Ramsey reported that he has prepared a grant application to the Environmental Protection Agency for their Hazardous Material Cleanup Grant Program, which would be to clean up the interior hazardous materials within the Strathmore Mill.

- These are two separate companion applications. You can apply for up to two parcels.
- Each grant is capped out at \$200,000.
- There's a match required at \$40,000 for each project, which come from the appropriation that was made by the community a year ago. If these grants were to come through, the Town would look at spending close to \$80,000 much lower than the \$385,000 that Town Meeting allocated the Strathmore hazardous cleanup.
- The grant application is due November 16th, and Ramsey can accept comments from the public November 8th.
- The award would be made by April, and the construction period would require cleanup to be completed by 11/01/20.
- The design portion can be done before April because we have CDBG funding to do demolition design and abatement.
