- They will be there through Wednesday, doing a final system air balancing and a final walkthrough.
- We expect to get about \$2,000 in rebates.

# Jeff Singleton, FRTA Alternate Rep Request proposed FRTA bylaw change

Singleton presented and read aloud a draft of a proposed bylaw change in response to the process of making route changes without a public hearing. The FRTA Advisory Board shall not approve route changes that have not been proposed at least thirty days in advance of the board meeting at which the board considers the changes. The specific route changes being voted on by the board shall be subjected to public discussion through public hearings. The route changes shall also be presented to the governing bodies of affected towns at least thirty days in advance of the advisory board vote. This bylaw may be temporarily suspended in response to emergency conditions.

Kuklewicz stated that he would like to hear what the Rules Committee has to say and see if they have any suggestions on time frames; then this issue can be revisited.

## **Town Administrator's Report**

# Planning for retirement of the Town Building Inspector

Discussion:

- Jensen would like to retire sometime between February 2 and April 1.
- Among Jensen's goals are finishing the archiving and seeing Strathmore "buttoned up."
- A transition would involve a two-week overlap with the new Inspector having access to Jensen.
- An appropriation at Special Town Meeting would allow approximately 35 hours of Jensen's time.
- Ellis estimates the two-week overlap plan would be somewhere between \$9,000 and \$12,000 in costs.
- One of the challenges would be finding someone who would not only do the inspections, but also would cover
  the other assigned duties that have fallen into Jensen's realm.
- Montague is one of the few towns in Franklin County that has urban, manufacturing, and residential interests.
- Ellis will put together a screening committee, which will include Jensen, Ramsey, Karen Casey (office clerk), Ernie Brown (ZBA Chair), Bill Doyle (property owner and builder), Josh Lively (builder and member of Capital Improvements Committee), and Tom Wyman (alternate electrical inspector).
- Preliminary target dates include advertising before December 1st, asking people to respond by December 12th, and offering the position in early January.

# Topics not anticipated in the 48 hour posting requirements

Ellis mentioned that the boarding process at the Strathmore has slowed down due to the contractor's illness. The board wasn't pre-sprayed, which may be an issue as applying latex paint at appropriate operating temperatures is crucial. If the contractor is unable apply the paint before the spring, there may have to be an arrangement where they receive partial payment.
