Discussion regarding possible closing of Center Street Bridge, Montague Center

- Bergeron reports that he received a call last week from Mark Banecheski, who informed him that the bridge has been inspected as part of their program. Two of the stringers are pretty well gone. One option would be to completely close it down; the other option would be to put barriers and stop signs up stating that it is now one lane. It needs to be reduced to 3 tons. Bergeron would like to put some stop signs, barriers, and weight limit signs up for now.
- Years of road salts, weather, and flooding has caused the bridge to deteriorate. It will eventually become unusable and there is nothing that can be done to prevent the erosion.
- Bergeron had asked about the State helping with the bridge; it would be five years before they would even put it on their list of things to do. Closing the bridge would not make a difference in getting help earlier.

- The bridge does not qualify for the fund set aside for small bridges.
- Signal lights would cost \$8,000. Bergeron said that instead he may put flashing lights on either side.
- Bergeron and Banecheski will talk about a traffic plan.
- Information of the traffic management solution will be posted on the front page of the website once it is ready to be implemented.
- Another option would be getting the bridge on the TIP (Transportation Improvement Program) list as was the case with Greenfield Road, which was a \$5 million project.

Topics not anticipated in the 48 hour posting requirements Demolition Plan for Strathmore Mill

Ellis: We will be releasing an RFP for the design of an abatement and demolition plan for Strathmore Mill, using CDBG monies. It was originally envisioned as selective demotion that would focus on the north side of the facility. In viewing the building, and not wanting to pay for a study that might ultimately say "You can do selective demolition, but there is extremely high risk in doing so," we thought it would be important to expand the scope that would include a wider range of demolition (which would avoid Building 9 and Building 11). We are seeking the Board's approval to expand the scope of demolition. This will give us a better opportunity to put us in line if grant money becomes available.

Kuklewicz: Let's give the engineers a chance to look at it all and come back with their thoughts.

Location of Personnel Files

Boutwell: I would like our Town Administrator to look into personnel files that are located throughout town and putting them into one location.

Ellis: We might think through the fact that it may be appropriate for certain files not to be located in this specific location, and that exactly what is where is entirely catalogued. This is part of the broader look of personnel policy.
